The President's salary is set by the College's Compensation Committee. The purpose of the committee is to review the President's job performance and determine the appropriate salary to recommend to the full Board of Trustees. The Trustees meet in Executive session during the annual May meeting to receive the report of the Compensation Committee and act on their recommendation. The actions of the Board of Trustees while in Executive session are documented in the minutes of the meeting. In October 2010, the College obtained the services of an independent consultant to analyze the President's compensation package with Presidential compensation data from approximately ten (10) to fifteen (15) comparator colleges.

Lynchburg College (St Lucia) Limited, which is the branch campus on the island, is located in rented office and classroom space near the capital city of Castries. The program offerings are designed to respond to educational needs in St Lucia as well as other countries within the Eastern Caribbean. Specific areas of study include undergraduate programs in special education and elementary education, along with several graduate level programs. The for-profit entity or subsidiary provides a legal corporation that is recognized by the government of St Lucia. Lynchburg College (St Lucia) Limited includes the rental of the office and classroom space, necessary property or liability insurance for operations, employment of St Lucia citizens as the on-site director and administrative assistance, and other miscellaneous expense such as equipment purchases for the educational operations on the island. All of the educational activities fall under Lynchburg College in Virginia. Lynchburg College in Virginia is the sole shareholder of stock in the for-profit subsidiary, and as such controls the membership of the board and can direct financial decisions affecting the subsidiary and the College. The directors selected for the subsidiary also serve as board members of Lynchburg College in Virginia, so they represent the interests of the College. No fundraising will be undertaken by the for-profit entity, Lynchburg College (St Lucia) Limited.
