COMMUNITY IMPACTUWCV RAISED OVER \$2.9M DURING ITS ANNUAL CAMPAIGN TO MAKE AN IMPACT ON MORE THAN 66,000 UNDUPLICATED INDIVIDUALS IN CENTRAL VIRGINIA. NEEDS WERE EVALUATED BY VOLUNTEERS WHO MADE FUNDING RECOMMENDATIONS TO THE UNITED WAY BOARD FOR APPROVAL. THE UNITED WAY BOARD OF DIRECTORS VOTED UNANIMOUSLY TO MOVE FROM PROGRAM FUNDING TO AN ISSUE-FOCUSED ORGANIZATION. THE FIRST ISSUE TO ADDRESS IS EDUCATION READINESS. SMART BEGINNING CENTRAL VIRGINIA SMART BEGINNINGS CENTRAL VIRGINIA IS AN AREA-WIDE COALITION OF AGENCIES, EARLY CHILDHOOD EDUCATORS, HEALTH PROVIDERS, BUSINESSES, AND COLLEGES THAT WORKS TOGETHER TO ENSURE THAT AREA CHILDREN ENTER KINDERGARTEN READY TO LEARN. THIRTY-SEVEN EARLY CHILDHOOD PROGRAMS AND FIVE FAMILY DAY HOMES PARTICIPATED IN THE VIRGINIA STAR QUALITY INITIATIVE.
