Investing in Education - School Success UWVP helps children and youth achieve their potential through education We invested \$975,199 in the academic success of 38,881 children and youth residing on the Virginia Peninsula We focused our investment in two program areas - academic support and preschool access Of the aforementioned investment, \$700,461 was invested in academic support initiatives that served 37,641 Academic support initiatives promoted school success through mentorships, afterschool and summer programs The remaining \$274,738 was invested in research-based, early intervention preschool services that served 1240 children, 921 of which were identified with acute developmental delays

Responding to Basic Needs - Self Sufficiency UWVP helps families become financial stable and independent Through a \$1,099,416 investment in self-sufficiency initiatives, UWVP funded programs touched 117,022 residents on the Virginia Peninsula Our investment strategy focused on two program areas - basic needs and empowerment Basic needs programs were funded at a level of \$860,580, these programs provided nutritional food and safe shelter for people in crisis Supported programs included a food distribution program that distributed more than 9 million pounds of food to 74,570 residents, sheltering programs that served 13,552 people, and homelessness intervention efforts that avoid eviction or utility termination for 14,241 families Another 2,529 adults were meaningfully impacted by our \$238,836 investment in empowerment program areas These programs promoted adult literacy, supported employment for the disabled, helped probationary adults re-enter the workforce, and provided financial literacy services to those with low to moderate incomes

Improving Health & Wellness - Community Health UWVP helps residents enjoy physical, mental, and emotional wellness UWVP invested \$520,870 in community health initiatives that served 18,443 people across four program areas -- healthy choices, independent living, affordable healthcare, and domestic violence support We invested \$135,900 in healthy choices initiatives that provided supplemental health education and counseling services to 6,110 residents We invested \$75,400 in two free clinics serving 3,183 uninsured individuals and another \$45,050 in programs that helped 2,967 seniors and disabled adults live independently Individuals experiencing domestic violence were protected and supported through counseling, supervised visitation, and legal advocacy programs within the domestic violence support program area This program area received \$264,520 and served 5,583 clients
