THE RAPPAHANNOCK FOUNDATION FOR THE ARTS PRODUCES PERFORMING ARTS GROUPS FOR THE CULTURAL ENRICHMENT OF THE COMMUNITY. DURING THE FISCAL YEAR ENDED JUNE 30, 2014, FIVE SHOWS WERE STAGED BY THE RFA WORKING ALONE. 1,918 PERSONS ATTENDED THESE SHOWS, AND 101 PERSONS PERFORMED AT THEM. THE VENUE FOR THESE SHOWS WAS FILLED TO AT LEAST 80% CAPACITY FOR ALL THE SHOWS. IN ADDITION, THE RFA CO-SPONSORED TWO EVENTS, WITH ANOTHER 646 IN ATTENDANCE. THESE PRODUCTIONS BROUGHT ORCHESTRAL MUSIC, BROADWAY-STYLE SINGERS, A NATIONALLY KNOWN FLAMENCO DANCE TROUPE, AND TWO FOLK MUSIC ACTS TO THE AREA. NO OTHER LOCAL AREA ORGANIZATION STAGED PRODUCTIONS OF A COMPARABLE QUALITY, OR ENABLED AS MANY RESIDENTS TO ENJOY THESE KINDS OF PERFORMING ARTS.

THE RAPPAHANNOCK FOUNDATION MADE GRANTS TO AREA ORGANIZATIONS THAT SUPPORT THE PERFORMING ARTS. THIRTEEN GRANTS WERE MADE DURING THE FISCAL YEAR. APPROXIMATELY 9,600 PERSONS ATTENDED THE PERFORMANCES MADE POSSIBLE BY THESE GRANTS, AND ANOTHER 1,912 PERSONS PERFORMED AT THEM. THESE PRODUCTIONS INCLUDED MUSIC, VISUAL ARTS, AND DRAMA.
