Library of VA will work with staff of Encyclopedia VA/VFH to select biographical entries, compile preliminary master list of grant-themed topics, identify resources and media content, hire assistant editor to research, write, and fact biographies.

(2) University of Virginia

Work with staff of Documents Compass/VFH project to identify accurately those documents to be published and to obtain copies of preliminary transcriptions and/or facsimiles of those requiring transcription and convert initial document transcription into standard format for online display, transmitting these transcriptions to VFH project website.

To assist staff of Documents Compass/VFH with identification of person records and to update PFE revision data as well as spot-checking and quality control with the digitized material from the institution.

(3) Virginia Association of Museums

Funds to support museum programs and museum professionals throughout the state.

(4) Eastern Shore of Virginia Historical Society

Funds to support a one-day symposium focusing on the novel *To Kill A Mockingbird* and the its meaning in light of the history of racial segregation on Virginia's Eastern Shore.

Funds to support design and printing costs for a brochure describing the collections and programs of eleven museums and historical societies on Virginia's Eastern Shore--all members of the VFH-sponsored Eastern Shore Museum Network.

Funds to support collection and transcription of oral history interviews and a public symposium focusing on mid-20th century farm life on Virginia's Eastern Shore.

(5) Paul D. Camp Community College

Funds to support a series of oral history interviews with key individuals involved in peanut farming and marketing in Virginia's Western Tidewater region, the first step toward creating a community archive on peanut farming history, and the next step leading to development of a one-hour documentary film on the same subject.

Funds to support pre-production funding in support of a documentary film on peanut farming and economy in Virginia's Western Tidewater region.

Funds to support production of a one-hour documentary film on peanut farming and economy in the Western Tidewater region of Virginia. Specifically, this grant supports editing costs for two versions of a "trailer" for school and community use. Earlier VFH grants have funded script development and filming interviews with local farmers, historians, and business leaders.
