THE PURPOSES OF CHRISTIAN RELIEF SERVICES ARE TO PROVIDE FUNDING, SERVICES AND CRITICALLY NEEDED GOODS TO HELP PEOPLE IN COMMUNITIES STRIVING TO BREAK THE STRANGLEHOLD OF POVERTY AND TO HELP DEVELOP AND IMPLEMENT SUSTAINABLE SOLUTIONS TO THE NEEDS OF THESE COMMUNITIES. MANY COMMUNITIES WITHIN THE U.S. AND THROUGHOUT THE WORLD ARE TRAPPED IN CYCLES OF POVERTY AND SUFFERING BECAUSE THEY LACK BASIC INFRASTRUCTURE SERVICES FOR CLEAN WATER, MEDICINE, EDUCATION, HEALTH CARE AND HOUSING.
