The undersigned certify that:

1. They are the president and the secretary, respectively, of Alliant International University, a California nonprofit public benefit corporation.

2. The Articles of Incorporation of this corporation are amended and restated to read as follows:

1. The name of the corporation is: Alliant Educational Foundation.

2. (a) This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for public purposes.

(b) This corporation is organized exclusively for public, charitable, scientific, literary or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (the "Code") or the corresponding provision of any future United States internal revenue law. The specific purposes of this corporation are (1) to foster and promote post-secondary education and training in the fields of psychology, business, liberal arts, education, law and other educational subjects including, without limitation, research, professional training, practice and internships; and (2) engage in any other charitable activity related to education and training.


