4a (Code) (Expenses \$ 107,153 including grants of \$) (Revenue \$)

The drug prevention program at the Brooke Hancock Family Resource Network works towards reducing substance abuse in Brooke and Hancock counties through prevention focused on youth and families. We provide educational resources, evidence-based prevention education to local schools, and maintain a library of prevention materials for distribution throughout the community to promote an alcohol and drug free life style. These initiatives are made possible by working with the federal Drug Free Communities and the statewide Substance Abuse Prevention programs. An estimated 40,000 residents have heard or seen our messages through local media campaigns including television spots, radio spots, billboards, and newspaper inserts. We support youth initiatives by hosting a local RAZE Crew, a youth lead anti-tobacco program consisting of 11 current members, in addition to supporting other Crews in the community.

4b (Code) (Expenses \$ 68,419 including grants of \$) (Revenue \$)

The Parents as Teachers Program is an in home family education program that works with families who are prenatal through kindergarten entry. Certified parent educators conduct twice monthly home visits that center on the child's development as well as working to strengthen the family. In addition to home visits the program offers monthly group connections, where families come together to support and encourage each other.

Our Family Resource Center is a safe place for families to receive material on their childrens development and parenting skills, and receive information and referrals to other community agencies and services as needed. The Center is open to all families in Hancock and Brooke counties. Our FRC offers support and coordination of services to address the needs of the community. Approximately 191 people visited our Center last year.
