THE MISSION OF PLM FAMILIES TOGETHER IS TO MOVE WAKE COUNTY FAMILIES FROM HOMELESSNESS TO STABLE HOMES THROUGH MENTORING, HOUSING SUPPORT AND CONNECTING TO COMMUNITY RESOURCES. IT IS OUR VISION THAT THERE WILL BE NO HOMELESS FAMILIES IN WAKE COUNTY. FROM JULY 1, 2013 - JUNE 30, 2014 WE ASSISTED 185 FAMILIES ALONG THEIR JOURNEY FROM HOMELESSNESS TO INDEPENDENCE. EIGHTY-ONE FAMILIES MOVED INTO STABLE HOUSING (AN INCREASE FROM 70 FAMILIES IN 2012-13). SEVENTY-SEVEN PERCENT OF ALL FAMILIES THAT ENROLL IN PLMFT HOUSING PROGRAMS (SHORT-TERM HOUSING AND RE-HOUSING) OBTAIN A LEASE OF THEIR OWN. WITH OUR RE-HOUSING PROGRAM ALONE, 76% OF FAMILIES ARE MOVING FROM ENTRY INTO THEIR OWN LEASE WITHIN 60 DAYS (AVERAGE TIME EQUALS 43 DAYS). EIGHTY-THREE PERCENT OF FAMILIES MAINTAIN THAT LEASE FOR AT LEAST 12 MONTHS FROM THE DATE THE LEASE IS SIGNED. THERE ARE THREE PHASES OF OUR WORK WITH FAMILIES: 1) PRE-HOUSED - WE HELP FAMILIES SEEK ADEQUATE, AFFORDABLE HOUSING WHILE THEY ARE LIVING TEMPORARILY IN OUR SHORT-TERM HOUSING OR OTHER COMMUNITY SHELTERS OR UNSHELTERED IN THE COMMUNITY. 2) HOUSING WITH ASSISTANCE - WHEN A FAMILY MOVES INTO AN APARTMENT UNDER THEIR OWN LEASE, PLMFT PROVIDES A LIMITED AMOUNT OF FINANCIAL ASSISTANCE TO HELP THEM GET STARTED. 3) STABILIZATION SERVICES - PLMFT MENTOR ADVOCATES CONTINUE TO PROVIDE SUPPORT AND CASE MANAGEMENT SERVICES FOR 12 MONTHS AFTER THE END OF INITIAL FINANCIAL ASSISTANCE.
