

The North Carolina Pre-Kindergarten (NC Pre-K) program provides high-quality educational experiences to enhance school readiness for eligible four-year olds. Risk factors and eligibility parameters are determined by the State of North Carolina. NC Pre-K providers utilize licensed teachers and standardized curriculum in the classroom in a 10 month program preparing children for Kindergarten. During the 2012-2013 fiscal year the RAPC provided funding to serve over 650 children in over 50 classrooms by contracting with school districts, Head Start centers, and private early care and education centers

Smart Start - North Carolina's innovative early childhood program. The RAPC Smart Start serves the children and families of western North Carolina by providing both in-house services and partnering with health departments, family resource centers and nonprofit organizations to provide early childhood care and education programs that include Parents as Teachers, on-site technical assistance for early education centers, professional development and incentives for early care educators, regional literacy programming, and early education subsidies for eligible families.

Family Support Network of Region A (FSNRA). As an affiliate of the Family Support Network of North Carolina, the FSNRA provides support for families with children who have special needs.
