Child Care Service Association Resource & Referral (CCSA R&R) - Regional child care resource and referral lead agency serving 7 counties. The organization partners with the Division of Child Development and Early Education (DCDEE) to administer 3 regional projects, Infant-Toddler Enhancement, Promoting Health Social Behaviors in Child Care Settings, and School-Age Quality Improvement. The child care resource and referral agencies in most local communities provide a variety of services that include referrals for parents seeking child care, early childhood resources and information for parents and child care professionals, early childhood training opportunities, consultation for child care-related issues, help with professional development and available materials, equipment and resources. 176 licensed programs received Technical Assistance (TA); 81 licensed School-Age (SA) classrooms/homes received TA; 446 licensed Preschool classrooms/homes received TA; 381 licensed programs entered into Childcare Aware in the region, 1,264 families received childcare referrals; 274 training sessions conducted; and 621.5 training hours delivered.

Child Links Child Care Resource & Referral provides free child care referrals to parents searching for child care as well as a free resource library with developmentally appropriate toys, books, resources, equipment, and materials for parents and care providers of young children. It is the only program that comprehensively offers child care providers professional development training, early childhood information, curriculum resources, use of computers, and materials such as lamination, die-cuts, and book-binding for lesson planning. ChildLinks serves as the lead agency for the seven-county child care resource and referral region. 683 early childhood professionals and 161 parents accessed resource rooms 4,806 times. 601 early childhood professionals from 113 child care facilities attended 68 professional development training. 410 families received referral services. 20 presentations/collaborations in the community were provided by ChildLinks staff.

Quality, Education, Support and Training (QUEST) works with child care facilities promoting quality care through consultations, classroom improvement plans, professional development plans and center-based or individual-based grant awards when funds are available. QUEST provided "Rising Star Incentives" (increased star-rated licensure) grants to 3 child care centers and homes ranging from \$750 - \$4,500 in early childhood vouchers for materials directly related to the environment rating scale assessment. QUEST provided consultations to 324 early childhood professionals caring for 2,183 children in 197 classrooms from 63 child care facilities. 19 child care facilities received consultation from QUEST to increase their star rating to a 4 or 5-star rated license. 25 child care facilities received consultation from QUEST to maintain their current star-rated licensure. 11 potential child care providers received consultation for opening a child care facility. 16 of 19 participating child care facilities that applied for a higher star-rated license received at least a 4-star rating. 24 of 25 participating child care facilities undergoing relicensure maintained or improved their current star rating to at least 4 stars. 19 of 19 classroom environments receiving technical assistance for incorporating the Creative Curriculum used all 7 mandatory components of Creative Curriculum.
