To date, the NBCC Foundation has provided scholarships to counseling students committed to serving rural, military, and minority communities in 25 states.

Each year, the Foundation awards \$5,000 scholarships to U.S. and non-U.S. GCDF students towards the goal of increasing the number of available professional counselors providing quality career development services. In doing so, the GCDF scholarship program plays an important role in the Foundation's mission to leverage the power of counseling by strategically focusing resources for positive change.

The Foundation provides administrative expertise for the NBCC Minority Fellowship Program, through which twenty-two doctoral students in counseling received \$20,000 education awards, training assistance, mentors and networking opportunities to enable them to successfully complete their programs, and take leadership roles in reducing the disparities in mental health care for minority populations. Donated advertising services valued at \$7,770.00 were received for this program.
