The Pre-Kindergarten Program provided educational experiences to at-risk four-year old children in order to enhance kindergarten readiness. The children attended five-star rated, licensed facilities. 137 children were served.

4b (Code:) (Expenses \$ 602,909 including grants of \$ 510,152) (Revenue \$ 0)
Child Care Subsidy Scholarships assisted eligible families residing in Wilson County by providing full or partial subsidy scholarships for quality child care. 197 children received scholarships to attend three-star or higher licensed child care facilities.

4c (Code:) (Expenses \$ 121,999 including grants of \$ 121,999) (Revenue \$ 0)
Parents as Teachers (P.A.T.) is an evidence based family strengthening program that increases parent knowledge about child development, results in positive parent-child interactions, identifies early child health and development problems, and connects families to the community supports they need so that children have the best possible start in life and continue to show positive gains into the elementary years. P.A.T. offers home visits, group connections, developmental and health screenings, and referrals to community resources. 50 families were served; 64 children benefited; 439 home visits were made by three parent educators.
