North Carolina Pre-Kindergarten (NC Pre-K) - A high quality pre-kindergarten program that serves children who are at risk and prepares them for success in school. Pre-kindergarten is a research-proven strategy for school readiness and provides educated teachers, small class sizes, low teacher-child ratios, research-based comprehensive curricula, and a focus on the whole child and family. 674 children were served during the year.

4b (Code:) (Expenses \$ **327,732** including grants of \$ **7,186**) (Revenue \$ **12,787**)

Child Care Resource and Referral (CCR&R) - Program promotes quality child care and ensures that children acquire the skills to succeed in kindergarten. CCR&R provides services to ensure that safe, high-quality, affordable child care is available; comprehensive consumer information on child care choices; parent support and training; capacity building; technical assistance, trainings, professional development and provider recognition and accomplishments. During the year, the achievements of this program include the following: 51 trainings provided to child care providers; 450 providers trained and 83% of providers exhibited increase in knowledge based on pre and post test scores; 663 instances of intense technical assistance and 221 professional development plans were completed or updated to increase quality in the classrooms and to provide a direct impact to the children served.

Parents as Teachers (PAT) - Program offers personal visits to family preference and the parent educator's recommendation and documented in the Personal Visit Record. 941 personal visits were conducted during the year. 29 group meetings were held with annual assessments. Referrals to community resources are provided to families on an as needed basis. PAT serves families throughout pregnancy until their child enters kindergarten (usually age 5). Although this program is open to all families with age appropriate children, the enrollment target established criteria, and priority may be given to families with other identified PAT risk factors.
