THE CENTER'S K TO COLLEGE MODEL SERVES ACADEMICALLY FOCUSED, LOW-INCOME STUDENTS IN OUT-OF-SCHOOL PROGRAMMING DESIGNED TO HELP THEM ACHIEVE IN SCHOOL, GAIN ENTRY AND GRADUATE FROM COLLEGE, AND BREAK THE CYCLE OF POVERTY IN THEIR FAMILIES

THE PIONEER SCHOLARS PROGRAM SERVES 1ST-8TH GRADE ACADEMICALLY FOCUSED LOW-INCOME STUDENTS. THIS OUT-OF-SCHOOL PROGRAM DEVELOPS A STRONG FOUNDATION OF ACADEMIC SKILLS IN ELEMENTARY AND MIDDLE SCHOOL TO ENSURE READINESS FOR SUCCESS IN A COLLEGE-PREPARED HIGH SCHOOL CURRICULUM. 23 TEACHERS, WITH THE SUPPORT OF 99 VOLUNTEERS, IMPLEMENTED INDIVIDUALIZED CURRICULUM FOR 77 STUDENTS IN 2013-14. THESE STUDENTS ATTENDED 129 DAYS DURING THE SCHOOL YEAR FOR 2.5 HOURS EACH DAY, AS WELL AS 23 DAYS DURING THE SUMMER FOR 4 HOURS EACH DAY. IN ADDITION TO THIS, FAMILIES PARTICIPATED IN ADDITIONAL ENRICHMENT ACTIVITIES AND PARENT EMPOWERMENT OPPORTUNITIES. STUDENT OUTCOMES WERE MEASURED USING THE WOODCOCK-JOHNSON TESTS OF ACADEMIC ACHIEVEMENT, SCHOOL REPORT CARDS AND STAKEHOLDER SURVEYS. ANALYSIS OF THESE DATA SOURCES INDICATE THAT STUDENTS MAKE SIGNIFICANT GAINS IN ACADEMIC, SOCIAL, AND PERSONAL SKILLS.

THE SCHOLARS TO COLLEGE PROGRAM SERVES ACADEMICALLY FOCUSED HIGH SCHOOL STUDENTS WITH DEMONSTRATED FINANCIAL NEED. THIS OUT-OF-SCHOOL PROGRAM IS DESIGNED TO ENSURE THAT STUDENTS REALIZE SUCCESS IN AND OUT OF SCHOOL, ULTIMATELY DEVELOPING INTO GRADUATING SENIORS WHO ARE SELF-ASSURED, SCHOLARSHIP-ELIGIBLE AND COLLEGE-READY. IN 2013-14 EDUCATORS PROVIDED INDIVIDUALIZED ACADEMIC, COLLEGE, AND CAREER GUIDANCE TO 85 STUDENTS. THESE STUDENTS PARTICIPATED IN 35 CURRICULUM NIGHT SESSIONS AS WELL AS A 20 HOUR SKILLS BASED "BOOT CAMP" IN THE SUMMER. IN ADDITION, EACH STUDENT RECEIVED 50 HOURS OF INDIVIDUALIZED SUPPORT OUTSIDE THE CENTER, AS WELL AS PARTICIPATED IN CENTER-FACILITATED ENRICHMENT ACTIVITIES, PARENT EMPOWERMENT OPPORTUNITIES, AND ADDITIONAL TUTORING PROVIDED BY 49 VOLUNTEERS WORKING A TOTAL OF 805 HOURS. STUDENT OUTCOMES WERE MEASURED USING REPORT CARDS, STANDARDIZED TEST SCORES, COLLEGE ACCEPTANCE RATES, FINANCIAL AID AWARDS, AND STAKEHOLDER SURVEYS. IN 2014 THE PROGRAM GRADUATED ITS THIRD CLASS OF SENIORS - ALL 10 OF WHOM ARE SET TO ATTEND COLLEGE IN 2014-15.

IN ADDITION TO THE K TO COLLEGE MODEL, LAST YEAR THE CENTER FACILITATED THE WORK OF 65 OTHER NONPROFITS, SCHOOLS, AND ORGANIZATIONS THAT UTILIZED THE MULTIPURPOSE ROOMS, GYMNASIUM, AND STAGE TO FURTHER THEIR IMPACT ON DURHAM. THE CENTER PROVIDED SPACE FOR FREE TO 90% OF THESE PARTNERS WHICH RESULTED IN OVER \$150,000 IN RENTAL SAVINGS FOR THESE ORGANIZATIONS. THESE PARTNERS USED THE CENTER TO DIRECTLY SERVE FAMILIES, COORDINATE THEIR OWN WORK, AND HOST SPECIAL EVENTS. FACILITY PARTNERS USED THE CENTER AN AVERAGE OF 62 HOURS A WEEK AND SERVED THOUSANDS OF STUDENTS AND COMMUNITY MEMBERS MONTHLY THROUGH THESE ACTIVITIES. WE SERVE AS THE PRIMARY HOME SITE FOR 26% OF OUR FACILITY PARTNERS AS WELL AS THE INCUBATOR FOR FOUR NEW ORGANIZATIONS.

THE SCHOLARS ON CAMPUS PROGRAM LAUNCHED IN 2012 AND SERVES OUR HIGH SCHOOL GRADUATES AS THEY TRANSITION TO COLLEGE. THE PROGRAM PROVIDES STUDENTS WITH COMPREHENSIVE PLANNING AND RELATIONSHIP-BASED SUPPORT TO ENSURE THAT THEY SUCCESSFULLY TRANSITION TO HIGHER EDUCATION AND TAKE FULL ADVANTAGE OF THE RESOURCES AVAILABLE TO THEM ON CAMPUS. THE 15 STUDENTS PARTICIPATED IN A RETREAT, STUDENT WORKSHOPS, AND INDIVIDUAL AND GROUP EDUCATION AND SUPPORT SESSIONS. IN ADDITION, EDUCATORS PROVIDE EACH COHORT WITH 5 HOURS OF SUPPORT WEEKLY. IN 2013-14, SIX STUDENTS COMPLETED SCHOLARS ON CAMPUS AND THE K TO COLLEGE MODEL AND HAVE NOW JOINED OUR ALUMNI NETWORK AS RISING JUNIORS ON THEIR CAMPUSES.
