All income of the Corporation, after payment of operating expenses, shall be distributed exclusively to, or expended for, the benefit of the College of Allied Health Sciences of GHSU pursuant to the provisions of the GHSU "College of Allied Health Sciences Practice Plan" and the "MCG Allied Health Sciences Practice Group Bylaws", and any amended or restated versions which may subsequently be duly approved and adopted.

VII.

The corporation shall have perpetual duration.

VIII.

The affairs of the Corporation shall be managed by a Board of Directors, all of whom shall be duly licensed by the State of Georgia or otherwise authorized by law to practice their respective disciplines. The Board of Directors shall have the general authority, power and responsibility set forth in Section 14-3-101 of the Georgia Nonprofit Corporation Code and those specific authority, powers and responsibilities set forth in these Articles of Incorporation and the Bylaws of the Corporation. The method of selection of the Board of Directors shall be determined by the Bylaws of the Corporation.

IX.

All full-time faculty of the College of Allied Health Sciences at Georgia Regents University and who are licensed by the State of Georgia or otherwise authorized to practice their respective discipline and any part-time faculty and credentialed staff who are approved for membership in accordance with the terms of the College of Allied Health Sciences Practice Plan shall be members of the Corporation by reason of their employment in the GRU College of Allied Health Sciences and shall remain a member until such time as they cease to be an employee of the GRU College of Allied Health Sciences. The authority, power and responsibility of members of the Corporation shall be determined by the Bylaws of the Corporation.

X.

These Articles of Incorporation and the Bylaws of the Corporation may be amended as provided in the Bylaws. All amendments shall be subject to the review and approval of the GRU President and the Dean of the College of Allied Health Sciences before such amendments shall become effective. Any amendments to these Articles or the Bylaws shall be consistent with the provisions of Section 1905 of the Policies of the Board of Regents of the University System of Georgia regarding "cooperative organizations."

XI.

In the event of the dissolution of the Corporation and to the extent allowed under applicable law, all of the assets of the Corporation shall be distributed to, or its assets sold and the proceeds distributed to, another nonprofit, cooperative organization of GRU as shall be determined and directed at the sole discretion of the GRU President and such assets or proceeds shall be held in a separate fund for the exclusive benefit of the GRU College of Allied Health Sciences. Any such cooperative organization receiving said assets or proceeds must qualify as exempt from taxation under Section 501(c)(3) of the Internal Revenue Code of 1986.
