Instruction - Rabun Gap - Nacoochee School is a 110-plus year old independent boarding and day school providing co-education college-preparatory in grades five through twelve that has a covenant relationship with the Presbyterian Church Rabun Gap - Nacoochee School (RGNS) educated approximately 400 students from 20 countries and 15 states for the current fiscal year with an average class size of 11 The Middle School had an enrollment of approximately 95 boys and girls International students comprise approximately 20 percent of the student body The faculty averages 15 years of teaching experience, with an average of 8 years at RGNS Of the 54 classroom teachers and 7 residential faculty, 75 percent hold graduate degrees or higher Advanced Placement (AP) courses are offered in all academic departments with over 100 students enrolled in an AP course and the majority of the AP candidates received a score of 3 or higher, making them eligible to receive college credit for their work With approximately 25 clubs and student organizations, students participate in a wide range of activities The international students have a diverse range of activities that include all types of generational contribution

Auxiliary Services - RGNS provides residential housing in seven residence halls on the 1,400 acre campus for the boarding students who make up over 50 percent of the student population Residence life includes many planned weekend activities, and the halls have amenities such as computer rooms, kitchens, laundry rooms, vending machines, and common areas In addition, the dining hall serves over 215,000 meals on an annual basis In addition, the bookstore and student center operate for the benefit of the students and faculty
