To support Palm Beach County STEM Initiative projectA STEM Council was created, composed of the private, nonprofit, public and philanthropic sectors, to work together as a community to enhance STEM education The Council created a strategic plan and formed subcommittees to work on teacher summer externships, high school internships, middle school mentoring, and marketing and branding of the work Implemented the Certified Instructional Coach program-a year-long professional development experience focused on developing facilitative leadership skills among STEM-focused district and area support staff, school-based math and science coaches and other teacher leaders One hundred and thirteen participants received training Fifteen district staff and area staff completed the required documentation through electronic portfolios and met the requirements for certification Thirty-two school-based personnel were on track for certification by May 2014 Thirty-five (35) teachers participated in the Summer Science Institutes with STEM researchers at UOF One hundred thirty-three (133) K-12 teachers attended six content clinics Subjects included DNA and Biotechnology, Fractions, Algebraic Functions, Cells and Human Body Systems, Weather & Climate and Problem-solving Offered a Graduate Certificate Program for 36 under-prepared teachers to build STEM content knowledge STEM teachers were invited to participate in a credit, 5-course STEM Master Teacher certificate program focusing on the development of basic STEM content and teaching skills Through an e-learning platform, 24/7 support in differentiated instruction through peer teaching and other supports and resources was provided to the Certified Instructional Coaches and teachers Eighty-three (83) participants have submitted 229 videos demonstrating their competency and application of the coaching concepts

To support "Summer Reading Slide 2014" Twenty high-poverty public schools received grants of up to \$10,000 to assist them in addressing the summer reading slide by providing access to print rich environments Children were provided with up to ten self-selected "just right" books to read over the summer Most schools offered opportunities for the children to exchange books over the summer Schools, to which children may walk, opened their media centers for book checkout and exchange during the week Opportunities to discuss books were offered The original goal of this effort was to help children maintain their reading levels Again this year, not only did the majority of participating readers maintain their reading levels, many increased their reading levels
