purchasing locally grown products, it supports the farmers and
the economy, but also helps reduce the carbon footprint.
The buying local movement is capturing the attention of
consumers and they are seeing the best source for fresh produce.
Many of our members participated in this campaign by using social
media, website and newsletters to make consumers aware of local
produce and products available.

7th Annual Miami International Agriculture Horse & Cattle Show.
DCFB has participated in the show each year bringing agriculture
to the urban area of Miami Dade County. This year we created an
Ag Venture for visitors of all ages to participate. We partnered
with Miami Dade County Extension Services, 4-H, University
of Florida, USDA, Florida Department of Agriculture and local
growers. The Ag Venture provided an opportunity to showcase South
Florida agriculture with a farmer's market and locally grown produce
from South Dade High Students FFA. There were over 30,000 attendees
for the 3-day event held at Tropical Park, FL.

We partnered with Fl. Ag in the Classroom and Miami Dade
Cooperative Extension to host a summer teacher workshop and
farm tour. The workshop educated teachers on the Florida Ag in

take back to their classrooms. Our goal was to begin planting the
seeds of agriculture in children. We also hosted a farm tour that
visited a Koi farm, an orchid farm and a fruit stand.
