THE SOUTHWEST FLORIDA SYMPHONY EMPLOYS AN INTERNATIONALLY ACCLAIMED CONDUCTOR, MORE THAN 65 WORLD-CLASS MUSICIANS AND BRINGS EXEMPLARY GUEST ARTISTS TO LEE COUNTY IN ORDER TO PROVIDE LEE COUNTY AND ITS VISITORS WITH THE HIGHEST CALIBER OF SYMPHONIC PERFORMANCES POSSIBLE. A PROFESSIONAL SYMPHONY ORCHESTRA IS THE CORNERSTONE OF ARTS AND CULTURE IN ANY COMMUNITY. THROUGH ITS STRONG PRESENCE AND RICH HISTORY IN SOUTHWEST FLORIDA, THE SOUTHWEST FLORIDA SYMPHONY SIGNIFICANTLY ENHANCES THE QUALITY OF LIFE IN ITS COMMUNITY. MANN PERFORMING ARTS HALL FOR A FULL SYMPHONY PERFORMANCE, CONDUCTOR AND GUEST ARTIST LED PRE-CONCERT LECTURES, FREE TICKETS FOR DISADVANTAGED YOUTH, 5 STUDENT RUSH TICKETS, THE DISCOVERY CLUB PROGRAM, WHICH PROVIDES STUDENTS IN K-12 WITH 5 TICKETS FOR STUDENT MEMBERS AND TWO GUESTS, PLUS SOCIAL ACTIVITIES TO KEEP CHILDREN ENGAGED WITH THE SYMPHONY AND MASTER CLASSES OFFERED AT LOCAL COLLEGES, LED BY VISITING GUEST ARTISTS. ADDITIONALLY, WE ENDEAVOR TO REACH UNDERSERVED COMMUNITIES BY BRINGING SYMPHONIC PERFORMANCES TO EVERY CORNER OF LEE COUNTY.
