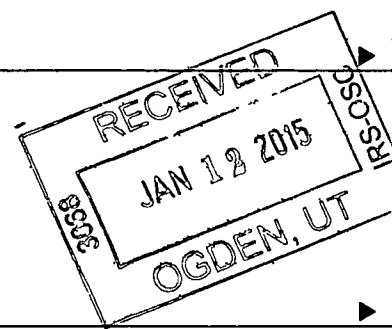

ALL ACTIVITIES RELATING TO THE RE-ENACTMENT COINCIDE WITH THE DATES OF THE ORIGINAL BATTLE WHICH WAS FOUGHT IN LATE FEBRUARY. THE NUMBER OF PEOPLE ATTENDING THE RE-ENACTMENT HAS STEADILY INCREASED EACH YEAR.
