CASA PROVIDES COMPREHENSIVE SERVICES TO EMPOWER SURVIVORS OF DOMESTIC VIOLENCE AND THEIR FAMILIES THROUGH 30 BED EMERGENCY SHELTER, 14 UNITS OF TRANSITIONAL HOUSING WITH A TOTAL OF 54 BEDS, A 24-HOUR CRISIS HOT LINE, SUPPORT GROUPS, YOUTH PROGRAMS, SUBSTANCE ABUSE ADVOCACY, INFORMATION AND REFERRAL PROGRAM, EMERGENCY RESPONSE TEAMS, LEGAL ADVOCACY, OUTREACH TO UNDER-SERVED COMMUNITIES, THRIFT CALLING THE CRISIS LINE SHELTER RESIDENTS RECEIVE CLOTHING, FOOD, AND PERSONAL ITEMS THE SHELTER HAS 30 BEDS CASA GATEWAY TRANSITIONAL HOUSING PROVIDES 14 INDIVIDUAL APARTMENTS AND AN ACTIVE PROGRAM
