The Children's Shelter Home, founded in 1985, is a residential ministry serving children who have been removed from parental custody by the state of Florida because of abuse or neglect. The Children, who stay for an average of 90 days, are cared for 24 hours per day and take part in all age-appropriate activities offered through the First Baptist Church of Leesburg, Inc. 190 foster children were admitted to the Children's Shelter Home during the year.

(Code) (Expenses \$ 283,958 including grants of \$ 59,241) (Revenue \$)

The Samaritan Inn (Homeless Family Shelter), opened in 2010. It serves homeless families who are not presently dealing with addiction or facing felony charges. The Samaritan Inn is currently Lake County's only shelter for intact homeless families. During the year a total of 58 families transitioned from homelessness to economic self-sufficiency.

(Code) (Expenses \$ 234,232 including grants of \$ 14,907) (Revenue \$ 39,431)

The Men's Residence, founded in 1982, is a residential ministry to men struggling with drug and alcohol issues. The Men's Residence has a five-month program which offers counseling, life skills, access to employment re-training and various other services as needed. The Men's Residence has an average 12-month post-exit sobriety rate of roughly 40 percent, approximately twice that of the national average. A total of 366 men were assisted via the Men's Residence and a total of 25,860 meals were served to the homeless and needy during the year.

(Code) (Expenses \$ 130,548 including grants of \$ 1,661) (Revenue \$ 3,545)

The Women's Care Center, founded in 1987, is a residential ministry to women, similar to that of the Men's Residence, but also caters to the sensitive side of recovery for those individuals with histories of sexual abuse. A total of 38 women were assisted and given shelter during the year.

(Code) (Expenses \$ 126,603 including grants of \$ 8,344) (Revenue \$)

The Pregnancy and Family Care Center, founded in 1989, serves families with children under the age of five who are dealing with issues related to poverty, abuse, neglect, and legal issues, as well as individuals confronting unplanned pregnancies. Childbirth and parenting classes are offered in this program, as well as assistance with clothing and baby needs. 947 women and teenagers were assisted in the Pregnancy and Family Care Center during the year.

(Code) (Expenses \$ 163,355 including grants of \$ 15,784) (Revenue \$)

The Benevolence Center, founded in 1991, serves more than 2,000 individuals with food, clothing, and other vital needs each month, including approximately seven tons of food each week. In addition, the Benevolence Center offers vouchers through the City of Leesburg for utility assistance when funds are available. 24,969 needy individuals received some form of assistance throughout the year. Additionally, the Fresh Start Job Program began operation in 2008 as a volunteer program. It is designed to provide help and assistance to individuals who are unemployed and seeking re-employment. Job referrals, career counseling, resume development and computerized job searches are available either by personal appointments or on-line by computer access. The need for help, assistance and direction is increasing daily and will continue for some time as unemployment in Lake and Sumter Counties continue to increase.
