The mission of the New World Symphony is to prepare gifted graduates of distinguished music programs for leadership roles in orchestras and ensembles throughout the world The New World Symphony, America's Or chestral Academy (NWS), offers a three-year postgraduate fellowship program focusing on musical technique, performance, audience development, and community engagement Founded in 1987 by Michael Tilson Thomas (MTT) and Ted Arison, NWS seeks to expand its 87 Fellows' musical and professional horizons beyond traditional conservatory training Visiting faculty offer master classes, coaching, private lessons, and advanced seminars in audition training, performance psychology, communications, and community engagement In addition, NWS Fellows perform weekly concerts, playing a diverse repertoire in an array of performance formats NWS envisions a strong and secure future for classical music, seeking to redefine, reaffirm, and share its traditions with as many people as possible NWS' ca

Orchestral Training Each year, more than 150 visiting artists and coaches work with NWS Fellows, offering master classes and private lessons as well as instruction in audition preparation, performance psychology, communications, and community engagement Instrumental coaches help prepare performance repertoire, lead sectional rehearsals, coach within ensemble settings, and play side-by-side with NWS Fellows in rehearsals and performances Fellows learn how to connect with audience members in the concert hall and in the community NWS' leadership development curriculum prepares Fellows to be self-confident, influential "artist-leaders" in whatever professional endeavors they pursue Leveraging the Internet2 network-a high speed, next generation Internet-NWS Fellows also conduct and receive lessons, master classes, interviews, and rehearsals with musicians, composers, and performers around the world In addition to this training, NWS Fellows participate in approximately 80 concerts over a 35-week season, offering a diverse repertoire through an array of performance formats to an annual audience of more than 60,000 South Florida residents and visitors Under the direction of Michael Tilson Thomas, artistic programming is designed to give Fellows as broad a performing experience as possible The repertoire includes solo, chamber ensemble, and full orchestra works ranging from compositions of the early 17th century to world premiere commissions In addition to an Orchestra Subscription Series, NWS programming includes a chamber music series, a children's series, late-night "club concerts", and a contemporary music series With awards from the American Society of Composers, Authors and Publishers in 2003, 2007, 2008, 2009, 2011, and 2012 for Adventurous Programming of Contemporary Music, NWS continually demonstrates its commitment to new music In the past five years, NWS has performed more than 15 world premiere pieces, most of which NWS commissioned or co-commissioned The result of a multi-tiered training approach is an ever-growing cadre of NWS Fellows and alumni equipped with a deeper understanding of diverse styles and traditions within classical music, the ability to articulate this in their playing, and the skill to share their deeper understanding with audiences and with the next generation of musicians In the 27 years since NWS' founding, nearly 1,000 alumni have gone on to make a difference in communities and organizations worldwide

Audience Research and Development NWS has linked several alternate performance formats-Mini-Concerts, PULSE Concerts, and Encounters Concerts-to ongoing audience research Confronted with an economic downturn, an aging audience, and more than a generation of potential audiences with limited exposure to classical music, orchestras nationwide have tested alternative ways to attract new audiences This effort is essential for orchestras' artistic and fiscal health NWS presents the following alternate performance formats - Mini-Concerts short, informal, educational performances that last approximately 30 minutes, priced at \$2 50 per ticket - PULSE Concerts late-night concerts (9 30 PM to 1 00 AM) which feature two visually enhanced performances in the concert hall and a third, "unplugged" performance, each of which is interspersed with a set of DJ-spun electronica Cocktail bars inside the hall, club-style lighting, and video projections mark these cutting-edge musical, social, and dance events - Encounters Concerts no-intermission educational performances lasting approximately one hour and featuring extended, introductory explanations of the music by a guest host and the conductor - WALLCAST Concerts the live projection of select NWS concerts onto the 7,000 sq ft front faade of New World Center These free, high-defintion broadcasts are viewed by audiences in Miami Beach SoundScape, an adjacent City-owned park equipped with a state-of-the-art surround stereo system Each of these outdoor presentations generates an audience upwards of 1,500 people with some attracting as many as 3,500 The cycle of data gathering, content refinement, marketing redesign, and performance is ongoing As part of this process, audiences are surveyed for their reactions to the alternate formats, this dialogue gives them a voice in the creative process and helps deepen their relationship to the Fellows, the music, and NWS NWS' alternate performance formats have attracted 5,139 new ticket buyers in the past five years, resulting in the sale of 13,881 tickets to first-time attendees Research has shown that 28% of the first-time buyers have come back once, with an additional 15% of them coming back twice or more often This number represents the new attendees that have come to NWS for the first time through an alternate performance concert, which is particularly impressive given that alternate performance formats comprise less than 15% of NWS' overall concert offerings Additionally, in a single year of research of NWS' WALLCAST Concert Club, a free membership program designed to learn more about WALLCAST concert audiences, NWS has registered more than 1,200 new-to-file attendees While this represents a significant amount of newcomers in a single year to a single concert format, it is believed that the actual number of new audience members to WALLCAST concerts is substantially under-reported and that NWS' reach is far greater, the number of registrants in our WALLCAST Concert Club represents only a fraction of actual attendees for each WALLCAST concert NWS is a leader in using digital technology to enhance classical music performance and education In September 2014, NWS publically launched its website MUSAIC, an online classical music video library of master classes, orchestral excerpts, how-to lessons, interviews, and performances This free repository serves classical music students, professionals, and aficionados Fellows benefit from its use as well while also creating new content for the site NWS maintains partnerships with nine major music schools, all of whom regularly contribute video content to the site As of May 1, 2015, MUSAIC has over 51,000 users and more than 2,700 registrants to the site NWS' most recent digital venture is a video-based exploration of the work of John Cage, one of the 20th century's most influential and provocative composers and visual artists "Making the Right Choices A John Cage Celebration" grew from NWS' three-day festival, presented in 2013, commemorating the centenary of Cage's birth This free, online resource is built around videos of works performed during the festival, behind-the-scenes rehearsal footage, and artist interviews During the opening session of their 2013 conference, League of American Orchestras President and CEO Jesse Rosen noted, "The New World Symphony is one of our beacons for taking innovation to the next level They have not only been testing new concert formats, but they have been adjusting as they go-getting audience input, evaluating the results, and collaborating with [partner orchestras in] San Diego, Charlotte, Memphis, Detroit, and Kansas City to extend the tests outward " NWS considers its work as a major step forward in bringing new ideas and research-based findings to the orchestra world

Community Engagement NWS believes that orchestral musicians should be ambassadors for classical music-as advocates, educators, mentors, and leaders NWS' Community Engagement Programs (i) prepare Fellows for leadership roles as educators, communicators, and role models, (ii) introduce children to classical music and the concert-going experience, and (iii) foster lasting and meaningful relationships between the orchestra and the community NWS' Community Engagement activities include the following - NWS in the Schools and Community Fellows visit area schools to make 45-minute interactive and thematic musical presentations aimed at helping students discover and become excited about classical music NWS Fellows also play in various other community venues, including hospitals, hospices, and senior centers - Inside the Music These intimate lecture-based performances are curated and hosted by NWS Fellows, providing an intimate glimpse into their craft Topics range from music appreciation to the historic context of composers - Rehearsal Observations During these visits, K-12 and college students observe NWS rehearsals featuring internationally renowned conductors and soloists Prior to rehearsal, students meet the Fellows to learn about both the musical pieces and the instruments - Education Concerts These concerts are designed for Miami-Dade and Broward County students in grades 6-12 Students and their teachers are introduced to major orchestral works and composers NWS provides free transportation for all attendees, and teachers receive a study guide to heighten the educational impact of the performance The concerts are recorded for an internet broadcast to students around the world later in the season - Side-by-Side Concert This program offers advanced young instrumentalists in grades 7 through 12 an opportunity to perform in the Side-by-Side Ensemble concert, in which they play alongside NWS Fellows Through this experience, participants and Fellows develop a musical working relationship as together they rehearse and perform various orchestral works Auditions are open to advanced string, woodwind, brass, and percussion students from across South Florida - MusicLab Launched in 2009, MusicLab is a 26-week program operating in four Miami-Dade County public schools Its goal is to offer the highest quality musical training to students in school-based band programs and to build and enhance Fellows' teaching skills These free programs help NWS Fellows to connect with diverse audiences and sharpen their presentation, speaking, and teaching skills Led by specialists from organizations such as the Carnegie Hall Academy, community engagement coaching ensures that Fellows are capable of sharing classical music with as many people as possible Each season, NWS reaches 12,500 youth, children, and adults through community engagement
