The Research Foundation accepts and administers contracts and grants from private sources, (i.e. non-U.S. Federal, State and Local government). The Research Foundation processed 161 proposals and 119 awards in the current year. The objective is to continue processing proposals and awards which are used in support of research at The Florida State University.

The Research Foundation (RF) operates EIGHT buildings with the objective of facilitating more Florida State University tenants to perform research. DURING THE 2014 FISCAL YEAR, THE RF TERMINATED THE LEASE AGREEMENTS WITH LCRDA FOR THE SHAW, JOHNSON, AND SLIGER BUILDINGS AS WELL AS THE GROUND LEASE FOR BUILDINGS A&B. LCRDA RETAINED OWNERSHIP OF JOHNSON, BUT SHAW, SLIGER, AND THE LAND FOR A&B WERE TRANSFERRED TO FSU, AND THE RF CONTINUED TO MANAGE THEM.

Administering income from funds provided to support Florida State University research departments and promote the University's academic liaisons. The expenses are net of contributions from FSU FOR \$700K (REIMBURSEMENT FOR PATENT AND COPYRIGHT EXPENSES) AND \$250K (REPAYMENT OF CAPITAL INVESTMENT IN THE MEDIUM VOLTAGE LAB).
