Deferred taxes have been provided for these amounts, resulting in a net deferred tax asset of approximately \$19,447,000 and \$16,460,000 at June 30, 2014 and 2013. A full valuation allowance has been provided at both June 30, 2014 and 2013, to offset the deferred tax asset since the Health Ministry has determined that it is more likely than not that the benefit of the net operating loss carryforwards will not be realized in future years.
