Training Academies in Construction, Healthcare Careers and Business Administration model real-world experiences, pay trainees a weekly \$100 stipend and require them to demonstrate that they are responsible and respectful by showing up every day, on time, drug free, dressed professionally and with a good attitude TSJs training is conducted over 16-20 weeks and is delivered in a boot camp style to support completion and allow youth to transfer quickly to the workplace and higher wages Contextualized basic skills remediation, financial assistance for childcare and transportation and 32 hours of both life skills and job readiness training are embedded into the curriculum
