1. Description of Organization and Summary of Significant Accounting Policies

A. Organization

Community United Methodist Hospital, Inc. (the Hospital) is a not-for-profit organization operating an acute care hospital, a critical access hospital, a medical equipment service, and medical outpatient clinics, serving primarily Henderson, Webster and Union Counties in northwestern Kentucky. Admitting physicians are primarily practitioners in the local area. The Hospital was incorporated in Kentucky in 1948.

B. Principles of Consolidation

The accompanying financial statements include the accounts of Community United Methodist Hospital, Inc. and the following affiliated organization: Community Care Network, Inc. All significant inter-company transactions and balances have been eliminated in consolidation.

C. Use of Estimates

The preparation of the consolidated financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the consolidated financial statements and the reported amounts of revenues and expenses during the reporting period. Significant estimates include allowances for contractual allowances and bad debts, third-party payor settlements, self-insurance liabilities, derivative instruments, accrued pension liability, and other liabilities. Actual results could differ from those estimates.

D. Cash and Cash Equivalents

Cash and cash equivalents include investments in highly liquid debt instruments with a maturity of three months or less when purchased, excluding those amounts included in assets whose use is limited or restricted.

The Hospital routinely invests its surplus operating funds in certificates of deposit, repurchase agreements, and money market mutual funds. These funds generally invest in highly liquid U.S. government and agency obligations.

At June 30, 2014, Community United Methodist Hospital, Inc. maintained deposits of \$27,220,753 at seven financial institutions. Of these bank balances, \$1,750,000 was covered by federal depository insurance, \$1,433,946 were repurchase agreements with various financial institutions secured by mortgage-backed U.S. government agency securities, \$7,862,456 was secured by pledged collateral and the balance \$17,608,297 was neither insured nor collateralized as of June 30, 2014. However, management believes that the credit risk relating to these deposits is minimal due to the underlying nature of these investments.

E. Patient Accounts Receivable

Patient accounts receivable for services rendered are reflected on the balance sheet net of allowances for estimated uncollectibles from patients, third-party payors and others. Contractual allowances of Hospital charges are given to Medicare, Medicaid and certain approved commercial health insurance providers and preferred provider organizations. These payers routinely review patient billings and deny or limit payments for certain charges that they deem medically unnecessary or performed without appropriate pre-authorization. Allowances and denials are recorded as reductions of net patient service revenue. Accounts receivable from these third-party payors have been adjusted to reflect the difference between charges and the estimated reimbursable amount. These allowances are determined based upon periodic review of account balances, including the age of the receivable, payor classifications and the application of historical experience with the payor based on insurance type and collection experience.

F. Other Receivables

Other receivables are reported at net realizable value. Other receivable balances are written off when they are determined to be uncollectible based upon management's assessment of individual accounts. The allowance for doubtful collections is estimated based upon historical collection experience and management's assessment of their collectability.

G. Investments

Investments in equity securities with readily determinable fair values and all investments in debt securities are measured at fair value in the balance sheet. Investment income or loss (including realized gains and losses on investments, interest and dividends) is included in the excess of revenues over expenses unless the income or loss is restricted by donor or law. Unrealized gains and losses on investments are excluded from the excess of revenues over expenses unless the investments are trading securities. Donated investments are recorded at fair value at the date of receipt, which is then treated as cost.

H. Assets Limited or Restricted as to Use

Assets limited or restricted as to use primarily include assets held by trustees under loan agreements, set aside in accordance with agreements with third-party payors; and designated by the Board of Directors for future capital improvements and self-insurance reserves, over which the Board retains control and may at its discretion subsequently use for other purposes. Amounts required to meet current obligations of the Hospital have been reclassified in the balance sheet at June 30, 2014 and 2013.

I. Inventories

Inventories are stated at lower of cost, determined primarily by the first-in, first-out method, or market. Inventories consist primarily of medical, surgical, and pharmaceutical supplies.

J. Cost of Borrowing

Deferred financing costs associated with the issuance of the notes payable to Henderson County are being amortized on the straight line method over the term of the debt. Amortization expense charged to the statement of activities for the years ended June 30, 2014 and 2013 was \$20,142.

K. Property and Equipment

Property and equipment acquisitions are recorded at cost. Depreciation is provided over the estimated useful life, based on American Hospital Association guidelines, of each class of depreciable asset and is computed using the straight-line method. Equipment under capital lease obligations is amortized on the straight-line method over the shorter period of the lease term or the estimated useful life of the equipment. Such amortization is included in depreciation and amortization in the financial statements. Interest cost incurred on borrowed funds during the period of construction of capital assets is capitalized as a component of the cost of acquiring those assets. Capitalized interest is reduced by the amount of investment income earned on unexpended proceeds from project specific borrowings.

Gifts of long-lived assets such as land, buildings, or equipment are reported as unrestricted support, and are excluded from the excess of revenues over expenses, unless explicit donor stipulations specify how the donated assets must be used. Gifts of long-lived assets with explicit restrictions that specify how the assets are to be used and gifts of cash or other assets that must be used to acquire long-lived assets are reported as restricted support. Absent explicit donor stipulations about how long those long-lived assets must be maintained, expirations of donor restrictions are reported when the donated or acquired long-lived assets are placed in service.

L. Temporarily and Permanently Restricted Net Assets

Temporarily restricted net assets are those whose use by the Hospital has been limited by donors to a specific time period or purpose. Permanently restricted net assets have been restricted by donors and are to be maintained by the Hospital in perpetuity. As of June 30, 2014 and 2013, the Hospital had no permanently restricted net assets.

M. Excess (Deficiency) of Revenues Over Expenses

The statement of operations includes excess (deficiency) of revenues over expenses. Changes in unrestricted assets, which are excluded from the excess (deficiency) of revenues over expenses, consistent with industry practice, include unrealized gains and losses on investments other than trading securities, permanent transfers of assets to and from affiliates for other than goods and services, contributions of long-lived assets (including assets acquired using contributions which by donor restriction were to be used for the purposes of acquiring such assets) and changes in the pension liability other than net periodic pension cost.

N. Net Patient Service Revenue

The Hospital has agreements with third-party payors that provide for payments to the Hospital at amounts different from its established rates. Payment arrangements include prospectively determined rates per discharge, reimbursed costs, discounted charges, and per diem payments. Net patient service revenue is reported at the estimated net realizable amounts from patients, third-party payors, and others for services rendered, including estimated retroactive adjustments under reimbursement agreements with third-party payors. Retroactive adjustments are accrued on an estimated basis in the period the related services are rendered and adjusted in future periods as final settlements are determined.

O. Donor-Restricted Gifts

Unconditional promises to give cash and other assets to the Hospital are reported at fair value at the date the promise is received. Conditional promises to give and indications of intentions to give are reported at fair value at the date the gift is received. The gifts are reported as either temporarily or permanently restricted support if they are received with donor stipulations that limit the use of the donated assets. When a donor restriction expires, that is, when a stipulated time restriction ends or purpose restriction is accomplished, temporarily restricted net assets are reclassified as unrestricted net assets and reported in the statement of operations as net assets released from restrictions. Donor-restricted contributions whose restrictions are met within the same year as received are reported as unrestricted contributions in the accompanying financial statements.

P. Charity Care

The Hospital provides care to patients who meet certain criteria under its charity care policy without charge or at amounts less than its established rates. Because the Hospital does not pursue collection of amounts determined to qualify as charity care, they are not reported as revenue or receivables.

The amount of charges foregone for services and supplies under the Hospital's charity care policy aggregated to \$7,395,117 and \$9,973,737 in the years ended June 30, 2014 and 2013, respectively.

Q. Compensated Absences

Compensated absences are accrued when the employee's right to receive compensation for future absences is earned.

R. Estimated Malpractice Costs

The provision for estimated medical malpractice claims includes estimates of the ultimate costs for both reported claims and claims incurred but not reported.

The Hospital is a not-for-profit corporation and has been recognized as tax-exempt pursuant to Section 501(c) (3) of the Internal Revenue Code and applicable state law. The Hospital is entitled to rely on this determination as long as there are no substantial changes in their character, purposes, or methods of operation. Management has concluded that there have been no such changes, and therefore the Hospital's status as exempt from federal income taxation remains in effect.

The state in which the Hospital operates also provides a general exemption from state income taxation for organizations that are exempt from federal income taxation. However, the Hospital is subject to federal and state income taxation at corporate tax rates on unrelated business income. Exemption from other state and local taxes, such as real and personal property taxes is separately determined.

The accounting standard on accounting for uncertainty in income taxes, which addresses the determination of whether tax benefits claimed or expected to be claimed on a tax return, should be recorded in the financial statements. Under this guidance, the Hospital may recognize the tax benefit from an uncertain tax position only if it is more likely than not that the tax position will be sustained in examination by taxing authorities, based on the technical merits of the position. Examples of tax positions include the tax-exempt status of the Hospital and various positions related to the potential sources of unrelated business taxable income (UBIT). The benefits recognized in the financial statements from such a position are measured based on the largest benefit that has a greater than 50 percent likelihood of being realized upon ultimate settlement. There were no unrecognized tax benefits identified or recorded as liabilities for fiscal year 2014 and 2013.

The effect of the tax status of the Hospital's affiliates is not material to the consolidated financial statements. There were no income taxes paid on unrelated business activities in the years ended June 30, 2014 or 2013.

The Hospital files forms 990 in the U.S. Federal jurisdiction and the State of Kentucky. The Hospital is generally no longer subject to examination by the Internal Revenue Service for years before 2010.

T. Goodwill

Goodwill represents the excess of cost over the fair value of assets acquired. Long-lived assets are reviewed by management for impairment whenever events and changes in business circumstances indicate the carrying value of the assets may not be recoverable.

U. Other Operating Revenues

The Hospital met compliance requirements to receive incentive payments for upgrading and implementing certified electronic health record (EHR) systems and becoming a meaningful user under the provisions of the American Recovery and Reinvestment Act of 2009. The Hospital recognized \$1,847,401 of meaningful use incentives during the fiscal year 2014 and reported this amount as other operating revenue in the accompanying consolidated statements of operations. The portion of the meaningful use incentive earned during fiscal year 2014 that was not yet received is \$227,911 and is recorded as other amounts receivable in the accompanying consolidated balance sheets.

V. Reclassifications

Certain items relating to prior year amounts have been reclassified in the financial statements to conform to current year's presentation. These reclassifications had no impact on the net assets previously reported.

W. Recent Changes in Accounting Standards

Effective July 1, 2012, the Hospital adopted the Financial Accounting Standards Board (FASB) Accounting Standards Update (ASU) No. 2011-07, *Presentation and Disclosure of Patient Service Revenue, provision for Bad Debts, and the Allowance for Doubtful Accounts for Certain Healthcare Entities*. ASU 2011-07 affects entities within the scope of Topic 954, Healthcare Entities that recognize significant amounts of patient service revenue at the time services are rendered even though the entities do not assess a patient's ability to pay. ASU 2011-07 required certain healthcare entities to change the presentation of their statements of operations by reclassifying the provision for bad debts associated with patient service revenue from an operating expense to a deduction from net patient service revenue. Management has adopted this change in the accounting beginning in fiscal year 2013.

2. Net Patient Service Revenue

The Hospital has agreements with third-party payors that provide for payments to the Hospital at amounts different from its established rates. A summary of the payment arrangements with major third-party payors follows:

A. Medicare

Inpatient acute care services and outpatient services rendered to Medicare program beneficiaries are paid at prospectively determined rates per discharge. These rates vary according to a patient classification system that is based on clinical, diagnostic and other factors. Inpatient nonacute services, certain outpatient services and defined capital and medical education costs related to Medicare beneficiaries are paid based upon a cost reimbursement methodology. The Hospital is reimbursed for cost reimbursable items at a tentative rate with final settlement determined after submission of annual cost reports by the Hospital and audits thereof by the Medicare fiscal intermediary.

A. Medicare, Continued

These cost reports have been audited and final settled for Methodist Hospital through June 30, 2012 and Union County Methodist Hospital through June 30, 2012. Methodist Hospital had cost reports reopened for the years 2008 and 2009 for additional bad debt inclusion.

B. Medicaid

The Department of Medicaid services has adopted the Medicare Prospective Payment System approach and implemented the Medicaid DRG payment system for inpatient services as of April 1, 2003. Prior to this date reimbursement was on a per diem basis. Outpatient services continue under the cost reimbursement methodology with the exception of emergency room services. They now pay on a three tier fixed price basis with final settlement determined after the submission and audit of annual cost reports.

These cost reports have been audited and final settled for Methodist Hospital through June 30, 2008 and Union County Methodist Hospital through June 30, 2012.

C. Other

The Hospital has also entered into payment agreements with Blue Cross and other certain commercial insurance carriers and preferred provider organizations. The basis for payment under these agreements includes prospectively determined rates per discharge, discounts from established charges, and prospectively determined daily rates.

Laws and regulations governing the Medicare and Medicaid programs are extremely complex and subject to interpretation. As a result, there is at least a possibility that recorded estimates may change by an unknown amount in the near term. The Hospital believes that it is in compliance with all applicable laws and regulations and is not aware of any pending or threatened investigations involving allegations of potential wrongdoing. While no such regulatory inquiries have been made, compliance with such laws and regulations can be subject to future governmental review and interpretation as well as significant regulatory action including fines, penalties, and exclusion from the Medicare and Medicaid programs. The Hospital's classification of patients and the appropriateness of their care are subject to review by the fiscal intermediaries administering the Medicare and Medicaid programs.

Patient accounts receivable are reduced by an allowance for uncollectible accounts. In evaluating the collectability of patients' accounts receivable, the Hospital analyzes its past history and identifies trends for each of its major payor sources of revenue to estimate the appropriate allowances for uncollectible accounts and provision for bad debts. Management regularly reviews data about these major payor sources of revenue in evaluating the sufficiency of the allowance for doubtful accounts. For receivables associated with services provided to patients who have third party coverage, the Hospital analyzes contractually due amounts and provides an allowance for doubtful accounts and a provision for bad debts, if necessary (e.g., for expected uncollectible deductibles and co-payments on accounts for which the third-party payor has not yet paid, or for payors who are known to be having financial difficulties that make the realization of amounts due unlikely.) For receivables associated with private pay patients (which includes both patients without insurance and patients with deductible and co-payment balances due for which third-party coverage exists for part of the bill), the Hospital records a significant provision for bad debts in the period of service on the basis of its past experience, which indicates that many patients are unable or unwilling to pay the portion of their bill for which they are financially responsible. The difference between the standard rates (or the discounted rates if negotiated) and the amounts actually collected after all reasonable collection efforts have been exhausted is charged off against the allowance for doubtful accounts.

The Hospital's allowance for uncollectible accounts for private pay patients increased from 89.1% of private pay accounts receivable at June 30, 2013, to 92.8% of private pay accounts receivable at June 30, 2014. In addition, the Hospital's private pay write-offs decreased approximately \$5.3 million from \$31,499,102 for fiscal year 2013 to \$26,134,337 for fiscal year 2014. Both changes were the result of current trends experienced in the utilization by and collections from private pay patients in fiscal year 2014. The Hospital has not substantially changed its charity care or uninsured discount policies during the fiscal years 2013 or 2014. The Hospital does not maintain a material allowance for uncollectible accounts from third-party payors, nor did it have significant write-offs from third-party payors.

The Hospital recognizes patient service revenue associated with services provided to patients who have third-party payor coverage on the basis of contractual rates for the services rendered. For uninsured patients that do not qualify for charity care, the Hospital recognizes revenue on the basis of its standard rates for services provided (or on the basis of discounted rates, if negotiated or provided by policy). On the basis of historical experience, a significant portion of the Hospital's uninsured patients will be unable or unwilling to pay for the services provided. Thus, the Hospital records a significant provision for bad debts related to uninsured patients in the period the services are provided.

The Hospital does not require collateral or other security in extending credit to patients; however they routinely obtain assignment of (or are otherwise entitled to receive) patients' benefits payable under their health insurance programs, plans or policies (e.g. Medicare, Medicaid, Blue Cross and other commercial insurance policies).

6. Debt and Obligations Under Capital Leases

A. Long-Term Debt

On December 30, 2009 and January 1, 2010, the County of Henderson, Kentucky issued Bonds in the principal sums of \$18,000,000 (Series 2009 B) and \$14,210,000 (Series 2010 A). The proceeds from these bonds were loaned by the County of Henderson, Kentucky to Community United Methodist Hospital, Inc. ("the Hospital") by promissory notes dated December 30, 2009 and February 16, 2010. These promissory notes were executed pursuant to loan agreements dated December 1, 2009 and January 1, 2010, respectively, between the lender and the Hospital. The proceeds of these issues were used by the Hospital to currently refund the outstanding principal balance of the County of Henderson, Kentucky Health Facilities Revenue Bonds, Series 2003 B and to pay for costs of issuance.

Under these agreements, the lender has agreed to loan to the Hospital the principal proceeds received from the sale of Health Facilities Refunding Revenue Bonds, Series 2009 B, and Health Facilities Revenue Bonds, Series 2010 A dated as of December 30, 2009 and January 1, 2010, respectively, to assist the borrower in the refunding of all outstanding Series 2003 B Revenue Bonds and in the financing of costs of the Project (as defined in the Agreement). The Hospital has agreed to repay such loans by making payments at the times and in the amounts set forth in the Note. The bonds are secured by, the Master Trust Indenture (the "Indenture"), dated as of December 1, 2009, between the lender and The Bank of New York Mellon Trust, Louisville, Kentucky, as trustee (the "Trustee"). The notes shall bear interest from their respective dates at a variable rate (adjusted weekly), payable on the 1st day of each month, commencing March 1, 2010. The Bonds shall mature on December 1 in the years and in the respective principal amounts set forth in the loan agreements.

On January 1, 2013, the County of Henderson, Kentucky issued Bonds in the principal sums of \$7,000,000 (Series 2013A). The proceeds from these bonds were loaned by the County of Henderson, Kentucky to Community United Methodist Hospital, Inc. ("the Hospital") by promissory notes dated January 1, 2013. These promissory notes were executed pursuant to loan agreements dated January 1, 2013 between the lender and the Hospital. The proceeds of these issues were used by the Hospital to refinance the outstanding principal balance of \$5 million of a taxable promissory note dated June 29, 2012 which were used for the acquisition, construction, equipping and installation of an air handling system, to acquire, equip and install certain medical equipment and other improvements related to the electronic medical record system and to pay for costs of issuance.

The plan benefits are based on years of service and the employee's compensation. Contributions are intended to provide not only for benefits attributed for service to date but also for those expected to be earned in the future.

11. Ambulance Service

The Hospital has agreements with the City of Henderson, Henderson County Fiscal Court, and Union County Fiscal Court to operate their respective county-wide ambulance services. The agreements provide for the Hospital to be reimbursed for any excess of the costs of operations over revenues earned. 13. Physician Receivables

The Hospital has contracted with various physicians and physician groups to advance funds for office renovations, assistance with malpractice insurance premiums, education loan payoffs, and income guarantee agreements. The Hospital provides income guarantee agreements to certain physicians who agree to relocate to the community to fill a need in the Hospital's service area and commit to remain in practice there. Under such agreements the Hospital is required to make payments to the physicians in excess of the amounts they earn in their practice up to the amount of the income guarantee. The income guarantee periods are typically two years. Such payments are recoverable from the physicians if they do not fulfill their commitment period to the community, which is typically three years. At June 30, 2014, the maximum potential amount of future payments under these agreements was approximately \$0.

Management estimates these advances (net of estimated uncollectibles of \$0 at June 30, 2014 and 2013, respectively) will be fully recovered in future periods.

15. Advertising Costs

Advertising costs are charged to expense as incurred. Advertising expenses for the year ended June 30, 2014 and 2013 were \$492,776 and \$794,257, respectively.

16. Facility Renovation and Expansion

Ongoing planning, development and implementation of various internal renovations and relocations continued during the 2014 fiscal year. Approximately \$1.5 million was invested during the year to upgrade and expand information systems technology as part of the Board of Directors initiative to fully implement an electronic medical record system. There were no additional significant project expenditures in fiscal year 2014.

17. Derivative

The Hospital entered into a "cash flow hedge interest rate swap" agreement with a notional amount of \$40,000,000 during the fiscal year ended June 30, 2006 with a financial institution. On February 16, 2010, the swap was amended to correspond with the Hospital's debt restructuring. The amended swap agreement was effective February 16, 2010, contains an outstanding notional value as of June 30, 2014 in the amount of \$25,726,000 and matures July 1, 2015. Based on the amended agreement the Hospital pays a monthly fixed interest rate of 3.475% and the financial institution pays a variable rate based on the variable rate index of "LIBOR" multiplied by 65% over the term of the agreement.

The Hospital entered into a cancellation agreement effective February 16, 2010 with the financial institution in order to cancel the Hospital's obligations under the original agreement and transition it's obligations to the amended swap agreement effective February 16, 2010. The Hospital incurred an early termination cost of \$183,835 which was paid on February 19, 2010. The remainder of the early termination cost was blended into the new amended swap agreement.

The Hospital's objective is to provide protection against market driven increases in variable interest rates. The fair value of the agreement was determined by the financial institution using the present value of the estimated projected cash flows. The Hospital is in a liability position as of June 30, 2014 and 2013 due to the present value of its estimated projected cash flows being more than the financial institution's present value of estimated projected cash flows. The derivative liability for the Hospital amounted to \$911,351 as of June 30, 2014 and \$1,735,445 as of June 30, 2013.

The total unrealized derivative gain recognized on the financial statements were \$824,094 and \$875,135 for the years ended June 30, 2014 and 2013, respectively. Upon termination of the agreement by the Hospital, prior to maturity, the gain or loss determined by the derivative fair value on that date would be realized.

18. Self-Insurance

The Hospital's Board of Director's elected to self-insure its professional liability and general liability as of November 1, 2003. Each Hospital (Methodist and Union County) is allocated and accrues its proportionate share of these liabilities.

For professional liability, the Hospital had \$1,000,000/\$3,000,000 aggregate self-insurance retention in 2014 and 2013. To pay claims in excess of the self-insured retention, the Hospital purchased an excess professional liability policy (claims-made basis). Losses from asserted claims and from unasserted claims identified under the Hospital's incident reporting system are accrued based on estimates that incorporate the Hospital's past experience, as well as other considerations including the nature of each claim or incident and relevant trend factors and incidents that may have occurred but have not been identified under the incident reporting system. As of June 30, 2014 and 2013, the Hospital had accrued approximately \$3,861,918 and \$3,990,999, respectively, which in the opinion of management, based on historical experience and current actuarial analysis, is sufficient to cover reported claims and claims incurred but not reported. The accrued professional liability has been discounted at a rate of 5.0 percent in 2014 and 2013.

18. Premier Initial Public Offering

The Hospital has an investment in a group purchasing organization, Premier, LP ("Premier"), which was recorded under the cost method at September 30, 2013. On October 1, 2013, Premier finalized an initial public offering and reorganized from a private company to a public company, Premier, Inc. As a result of the organization, the Hospital received Class B common units in Premier Healthcare Alliance, L.P (Premier LP). In connection with the reorganization and public offering, on October 1, 2013, the Hospital sold 15,673 of its Class B common units to Premier for approximately \$398,000 and recognized a gain of approximately \$367,000, which is included in net investment income on the statement of operations for the year ended June 30, 2014. Per the terms of an Exchange Agreement with Premier, Premier LP and limited partners of Premier LP (the Exchange Agreement), the Hospital may annually exchange up to one-seventh (1/7th) of its initial allocation of Class B common units and any additional Class B common units purchased by the Hospital through exercise of the right of first refusal over Class B common units proposed to be exchanged by other member hospitals as described in the Exchange Agreement. If exercised, for Class B common units so exchanged, the Hospital is entitled to receive either cash payments (from Premier or the other member owners under the right of first refusal), Class A

common stock. Cash payments will be determined per the terms of the Exchange agreement depending on whether the stock is traded on a national exchange, traded over-the-counter, or if there is no public market.

The exchange provision of the Class B common units is accounted for as vendor incentive equity-based payments to non-employees and the estimated fair value of the related units is recognized as a reduction of supplies expense over the vesting period when it is considered probable the units will vest. The estimated value of the Class B units involves significant assumptions, including that the Hospital will remain a member of the Premier group purchasing organization ("GPO"). The actual amounts realized as a result of the exchange provision vesting could be materially different.

In connection with the Reorganization, Premier also entered into a Tax Receivable Agreement with the member owners, including the Hospital. Premier has agreed to pay to the member owners a percentage of the amount of cash savings, if any, in tax that is Premier, Inc. realizes as the result of the increase in tax basis from the initial sale of Class B common units by the member owners, as well as certain other tax benefits realized. The Hospital recognizes the amounts receivable under this arrangement when they are communicated by Premier and known. The amount of any future tax receivable benefits under this arrangement, if any, cannot be reasonably estimated at the present time. Accordingly, no future benefits have been recognized in the accompanying financial statements.

Should the Hospital terminate its relationship under the Premier GPO, the Hospital must redeem its investment under the terms of its Partnership Agreement with Premier. The ultimate amount realized in the event of a termination could be materially different than the Hospital's carrying value of its investment.

20. Subsequent Events

The date to which events occurring after June 30, 2014, the date of the most recent balance sheet, have been evaluated for possible adjustment to the financial statements or disclosure is December 23, 2014, which is the date on which the financial statements were available to be issued.

In June 2014, the Hospital Board approved a motion to restructure the interest rate swap agreement on the variable interest debt. The revised swap agreement is anticipated to be effective July 1, 2015, and will contain an outstanding notional value in the amount of \$23,883,000 with a maturity of December 1, 2024. Based on the revised agreement the Hospital will pay a monthly fixed interest rate of 1.36% and the financial institution will pay a variable rate based on the variable rate index of "LIBOR" multiplied by 65% over the term of the agreement.

On August 1, 2014, the Hospital finalized the sale of its Home Medical Equipment operation. The Hospital received cash proceeds of \$345,000. The transaction resulted in a gain of approximately \$122,000. Additionally, the Hospital entered into a building lease agreement with the purchaser of the home medical equipment totaling \$40,000 per year. Lease term is a minimum of 24 months.
