In 1915, the Organization was originally granted a charter as a non-profit organization operating as a hospital. As reported in the 990 for the year ending June 30, 2010, the organization sold its hospital operations to an unrelated third party. FYE June 30, 2011, the Organization incurred reminent expenses for its former hospital operations that were not included or accrued in the prior financial statements. These expenses include legal and accounting fees for the settlement of the sales transaction, and other reminent costs. Inclusive of adjustments to third party payor reimbursements and liabilities.

The Board of Directors voted as of May 2010, the Organization could better serve its community through means other than operating non-profit hospitals. The Organization provides reasonably priced health care facilities in order to recruit and maintain healthcare providers to Clark County / Winchester, KY and surrounding counties which it has historically provided. The Organization is performing these tasks by continuing to maintain and rent real property retained by the Organization after the sale of its hospital operations.
