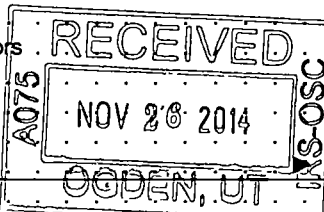



\$19,756 - Pyramid Awards: Grants given annually to teachers for innovative classroom instruction. Proposals are blind-scored and awards are given up to \$1,000 per teacher. A total of \$20,008 was presented in Pyramid Award grants in 2013.

\$25,000 - Reading Academy: Provides 90 hours of graduate-level instruction for current Oldham County Schools teachers in reading instruction. Last year, 64 teachers participated in this program.

\$2,000 - Oldham County Preschool: Grant to fund supplies and other needs at the preschool, which serves underprivileged and disabled students.

\$500 - donation to Oldham County Schools Arts Center dance program at donor's request.

\$12,000 - Artist-In-Residence program at OCS Arts Center. Provides educational opportunities for students at OCSAC and by visiting each school in the district to work directly with students.

\$18,000 - Gifted and Talented Educational Services materials, equipment, software and technology.

\$10,000 - grant to fund robotics clubs in each of the district's nine elementary schools.

\$4,000 - donation to support Project Graduation, an event for graduating seniors that occurs the night of graduation and lasts until morning, providing a safe, fun and drug- and alcohol-free environment.

\$500 - sponsorship of Yew Dell Botanical Gardens Sculpture Show, which allows all three district high schools to have art displayed as part of this juried sculpture show.
