Saint Thomas Rutherford Foundation (f/k/a Middle Tennessee Medical Center Foundation) provided a \$2 million grant to Saint Thomas Rutherford Hospital ("STRH") for the purchase of the new facility. In addition, the Foundation awarded a \$57,000 grant to STRH for bioterrorism emergency preparedness equipment, \$402,532 mobile health unit purchase, \$12,127.51 in conference and education expense reimbursements, and \$7,781 for associate nursing scholarships.

4b (Code _____) (Expenses \$ 5,130. including grants of \$ 5,130.) (Revenue \$ _____)

Provided assistance to 80 employees assisting with food cost, rent/mortgage payments, utility payments, car repairs, legal fees, insurance expense, property taxes, etc. Educational grants were provided to 8 STRH associates and 8 nursing scholarships were also granted to STRH associates. In total, 143 STRH associates were granted assistance from the Foundation.

Foundation provided grants to help with indigent families' expenses as well as grants to pay for indigent patient mammograms (487 mammograms). Foundation provided \$1,048 to patients needing Lymphedema compression garments for treatment.
