CRC ALSO ACTS AS THE CONDUIT BETWEEN THE CORPORATE WORLD AND THE NONPROFIT SECTOR FOR SURPLUS INVENTORY THAT FINDS A SECOND USEFUL LIFE RATHER THAN BEING THROWN AWAY.
