Form 990, part III, Line 4a		groups and continued assessment of needs and available resources is an effective tool in the periodic assessment of community needs and subsequent development of implementation strategies to address these needs. Assessment of Community Needs An internal hospital committee comprised of associates from Outreach Services, Planning and Marketing, Case Management, and Mission Services collaborated with the Alabama Quality Assurance Foundation to conduct a community needs assessment. The process began in 2012, and concluded with review, input and approval by the Hospital Board in April 2013. Leaders from local community agencies including Ozanam Charitable Pharmacy, Alta Pointe Mental Health Systems, Area Agency on Aging and others were interviewed and asked to identify the top five issues in our community. The rankings illustrated both the group's perceived level of importance of each item and the frequency at which each attendee thought a topic warranted outreach efforts. The top five issues considered to be of greatest need in the community were as follows: 1. Good Nutrition/Obesity Prevention 2. Diabetes Education and Support 3. Free/Subsidized Healthcare Services 4. Cardiac Health Education and Support 5. Mental Health Access and Support. Implementation strategies to address these needs were approved by the Board in April 2013. The strategies to address Good Nutrition/Obesity Prevention include the establishment of a community garden. In April, 2014, Dodd Nursery donated and constructed an enclosed garden on the Providence Hospital campus. Providence associates planted and maintained a summer garden and are now in the process of planting a fall garden. All the produce is given to Pelelope House, a local shelter for victims of domestic violence. Providence will also continue to address nutrition needs by preparing, delivering and serving meals to the women at McKemie Place, a shelter for homeless women. To address Diabetes Education and Support, Providence plans to develop a pilot disease management program for indigent, diabetic clients which will have a primary goal of reducing unnecessary admissions and complications by identifying barriers such as transportation, lack of coverage, the cost of medications, and understanding of the disease process. In addition, the Providence Diabetes Center staff will continue to provide diabetes education at no charge to the clients of Victory Health Clinic, provide foot checks to the homeless at the Homeless Connect program, and donate time to the American Diabetes Walk and the annual camp for children with diabetes. To address the 3rd identified need of Free/Subsidized Healthcare Service Providence applied for and was awarded a grant funded by the Affordable Care Act which allowed the Hospital to create the CARE (Coverage, Assistance, Resources, Eligibility) program. This program, designed to assist individuals with accessing and enrolling in healthcare coverage, has hosted 57 outreach events, reached 3536 consumers and successfully enrolled 595 individuals. Providence is providing a community wide tobacco cessation and prevention program at a reduced rate to address Cardiac Health Education and Support. The Hospital is also in the process of developing a fitness trail for the community on the hospital campus and will continue to support activities such as the Heart Walk and the Heart to Heart education series. Providence Hospital's goal in FY 14 is to work with the local chapter of the National Association for Mental Illness to address Mental Health Access and Support by providing staff education regarding how to care for mentally ill patients. In addition, the Hospital has provided conference rooms for NAMI meetings and sponsored several of their fundraisers to help families with expenses related to the caring for the mentally ill.
