The unauthorized transactions included the following areas: fraudulent expense reports, payment of a personal credit card with company funds, duplicate expense report reimbursements, and personal use of a company credit card. The documented loss amount for the period is \$461,237. In addition, there were questionable amounts which appeared improper but could not be verified due to the unavailability of acceptable documentation. The amounts totaled \$124,479. The CFO confessed to the embezzlement and was terminated from the Company. The Company filed a claim with its insurance carrier and received \$100,000 in fiscal year 2014 related to this fraud. Management anticipates additional recoveries from other parties. However, management cannot predict with reasonable certainty the exact amount or timing of any recoveries. As of the filing of this Form 990, the CFO has not corrected any of the reported excess benefit transactions. None of the company's organization managers (other than the CFO) knowingly participated in the above described transactions. The overall lack of segregation of duties surrounding the CFO led to her having access, reporting, and monitoring responsibilities in the accounts payable cycle, which allowed the issues to happen. In response, the Company has modified its internal control procedures to provide proper segregation of duties over the significant transaction cycles.
