produce, canned goods and frozen meats to senior  
housing centers where most of the residents  
receive assistance from the state and have no  
transportation.

As always, Farm Share tries to help out the  
school children in the "food desert" locations  
with afterschool snacks. All in an effort to  
improve the nutritional quality of the food they  
they receive.
