HUNGER FREE COLORADO LAUNCHED THE HUNGER FREE HOTLINE ASSISTANCE IN MAY 2011. THE TOLL-FREE, BILINGUAL HOTLINE IS A FREE "ONE-STOP" RESOURCE THAT OFFERS GEOGRAPHICALLY BASED REFERRALS TO FOOD ASSISTANCE PROGRAMS THROUGHOUT THE STATE OF COLORADO TO INDIVIDUALS IN NEED OF FOOD. DURING THE TWELVE MONTH PERIOD 7/1/13 TO 6/30/14, 6,622 HOUSEHOLDS RECEIVED INFORMATION ABOUT HOW TO ACCESS FOOD RESOURCES IN THEIR COMMUNITY. THESE RESOURCES INCLUDED FOOD PANTRIES, MEAL PROGRAMS AND FEDERAL NUTRITION PROGRAMS. THE SUPPLEMENTAL NUTRITION PROGRAM (SNAP), KNOWN AS THE FOOD ASSISTANCE PROGRAM IN COLORADO, IS A FEDERAL NUTRITION PROGRAM DESIGNED TO PROVIDE LOW INCOME HOUSEHOLDS WITH THE FINANCIAL RESOURCES TO PURCHASE GROCERIES. AS PART OF HUNGER FREE COLORADO'S WORK, WE PROVIDE TRAINING, TOOLS AND SUPPORT TO COMMUNITY PARTNERS THROUGHOUT THE STATE TO MAKE SNAP MORE ACCESSIBLE TO INDIVIDUALS AND FAMILIES. THE PROGRAM INCLUDES APPLICATION ASSISTANCE TO CLIENTS, SNAP OUTREACH TRAINING TO COMMUNITY PARTNERS, AND ASSISTANCE FOR COUNTY DEPARTMENT OF HUMAN SERVICES OFFICES. THE CHILD NUTRITION PROGRAM INCLUDES THE NO KID HUNGRY COLORADO CAMPAIGN, A PARTNERSHIP BETWEEN HUNGER FREE COLORADO, SHARE OUR STRENGTH, AND THE OFFICE OF GOVERNOR JOHN HICKENLOOPER TO END CHILDHOOD HUNGER BY 2015. THE CHILD NUTRITION PROGRAM ALSO INCLUDES WORK ON SCHOOL BREAKFAST, SUMMER AND AFTER SCHOOL MEAL PROGRAMS. CHANGE IN PROGRAMS. IN FALL 2013 AND EFFECTIVE DECEMBER 31, 2013, HUNGER FREE COLORADO'S BOARD OF DIRECTORS MADE THE DECISION TO OPT OUT OF A MULTI-YEAR, APPROXIMATELY 760,000 ANNUAL FUNDING CONTRACT, WITH SHARE OUR STRENGTH, A NATIONAL ANTI-HUNGER ORGANIZATION. CONCURRENT WITH THIS DECISION, THE ORGANIZATION'S BOARD OF DIRECTORS REDUCED OPERATING EXPENSES, HIRED A DIRECTOR OF DEVELOPMENT, AND BEGAN BROADENING OUR FUNDING BASE. THE COMBINATION OF THE LOSS OF SHARE OUR STRENGTH FUNDING AND THE TIME REQUIRED TO DEVELOP ALTERNATIVE SOURCES OF FUNDING RESULTED IN AN OPERATING SHORTFALL IN FISCAL YEAR 2014. MANAGEMENT AND THE BOARD OF DIRECTORS ARE ENCOURAGED BY THE CONTINUED SUPPORT OF LONG-TIME SUPPORTERS, AS WELL AS RECENT FUNDRAISING SUCCESSES AND ARE OPTIMISTIC REGARDING FISCAL YEAR 2015 PERFORMANCE.
