LSU FOUNDATION WAS THE GUARANTOR IN SUCH TRANSACTION. THE BONDS WERE FOR VARIOUS CONSTRUCTION PROJECTS, WHICH HAVE SINCE BEEN DONATED TO LOUISIANA STATE UNIVERSITY. THE OUTSTANDING BALANCE ON THE BONDS AT JUNE 30, 2014, WAS \$4,970,000. THIS BALANCE IS REFLECTED ON THE CONSOLIDATED BALANCE SHEET OF LSU FOUNDATION.

ONE CONSTRUCTION PROJECT INCLUDED IN THE REVENUE BOND ISSUANCE WAS A MULTI-FUNCTION ARTS FACILITY OPERATED BY THE SHAW CENTER FOR THE ARTS, LLC. THE LSU MUSEUM, LLC IS FIFTY-PERCENT OWNER OF THE SHAW CENTER FOR THE ARTS, LLC. THE LSU PROPERTY FOUNDATION IS THE SOLE MEMBER OF THE LSU MUSEUM, LLC. THE EQUITY INTEREST OF THIS INVESTMENT IS REPORTED ON THE CONSOLIDATED BALANCE SHEET OF THE LSU FOUNDATION, JUST AS THE ASSOCIATED OUTSTANDING LOAN BALANCE IS REPORTED.
