Expenses: Essentially, the money received was sent to the yearbook supply company. This year, the PTA subsidized the yearbook purchases by \$786. Expenses include supplies needed to advertise the yearbook sale to the parents, as well as training for personnel who compile the yearbook.

Supply Packs:

Objective: To ease the burden on parents purchasing beginning of the year student supplies. Also aids teachers in having similar supplies for all students as well as facilitate beginning of the year

classroom set-up. This is not a fundraiser. The PTA charges the same cost for each pack that we are charged. This is a PTA service for our parents.

Accomplishment: We sell 350-400 packs which are approximately 1/2 of the student population.

Expenses: Essentially, money received was sent to the supply pack company. A small rebate was received for meeting specific deadlines.
