Provide out-of-home care for children and therapeutic services to children and families in crisis Cookson Hills welcomes children into a supportive family environment within a safe community The community is based on a family-style living model Children are placed in homes staffed by dedicated ministry-oriented house parents They care for a maximum of 10 children, including their own in 11 homes A variety of effective therapeutic programs are used to reach the children we serve, and our programs are accredited and/or affiliated with eight state and national agencies Therapy models include cognitive/behavioral therapy, group therapy, family training, equine assisted psychotherapy, and play therapy In short, we use the most appropriate therapy to help us help the child, and we do so without any local, state or federal government funding
