THE BYLAWS MAY BE AMENDED, CHANGED OR REPEALED BY THE AFFIRMATIVE VOTE OF A MAJORITY OF THE MEMBERS REPRESENTED, AT ANY REGULAR OR SPECIAL MEETING OF THE MEMBERS IF NOTICE OF THE PROPOSED AMENDMENT, ALTERATION, CHANGE OR REPEAL BE CONTAINED IN THE NOTICE OF THE MEETING, OR BY THE AFFIRMATIVE VOTE OF THE MAJORITY OF THE BOARD OF DIRECTORS AT ANY REGULAR OR SPECIAL MEETING OF THE BOARD OF DIRECTORS.
