The president forfeits all interest in the retirement account in the event of termination for cause or voluntary termination for other than good reason as defined.

Martin: Included in Column B (iii) is a taxable housing allowance of \$45,000, taxable automobile allowance of \$4,068, taxable long-term disability insurance of \$380, taxable reimbursements of \$12,000 and employee deferred amount under section 457b plan of \$23,000. The payments of the taxable reimbursements, automobile allowance, long-term disability insurance and housing allowance are made pursuant to the terms of the contract with President Martin and the university.
