The Post Oak School provides a comprehensive Montessori education, recognized by the Association Montessori Internationale (AMI) and accredited by the International Schools of the Southwest (ISAS), to a diverse population of approximately 440 students from infancy to high school. In keeping with Dr. Montessori's ideals, children work in multi-age classrooms with a high level of freedom in choosing their own foundations in language, math, geography, science, music, and other disciplines. During the 2012-2013 school year, the school added a High School on a second campus located in the museum district of Houston which will incorporate the principles of Dr. Montessori as well as the International Baccalaureate.

The Post Oak School offers an extensive program of parent education. A free series of four classes, repeated throughout the year, offers general information about Montessori education to both prospective parents and interested visitors. The infant-parent program helps parents of toddlers to raise happy, self-confident children. A variety of other classes, lectures, and other presentations during the school year, some free and open to the public and others by reservation, afford a variety of perspectives on the School's primary purpose of raising intelligent, confident, caring, and self-motivated lifelong learners.

The School has established the Houston Montessori Institute to provide Associate Montessori Internationale training to teachers. It is the only AMI training center in the Houston area. The inaugural primary teacher training class began a 3-year course of study in the summer of 2013 with 19 students.
