Interfaith Ministries for Greater Houston brings people of diverse faith traditions together for dialogue, collaboration and service, as a demonstration of our shared beliefs. Interfaith Ministries for Greater Houston provides meals to homebound seniors, refugee resettlement assistance, interfaith relations services, and disaster preparedness services.

4a (Code:) (Expenses \$ 6,408,373 including grants of \$ 3,208,787) (Revenue \$ 260,264)
Senior Services includes the Meals on Wheels program and the AniMeals on Wheels program. Meals on Wheels delivers hot, nutritious weekday meals to homebound senior citizens, as well as breakfast and weekend meals to the most frail and isolated seniors. IMGH delivered 1.4 million meals, with an average of 4,000 seniors served each weekday in this fiscal period. 800 seniors received additional breakfast and weekend meals to supplement their daily lunch delivery. 180 seniors were assisted by IMGH social services staff, who provided case management and referrals to partner agencies for additional services. IMGH's special Thanksgiving meal, which was delivered almost exclusively by volunteers, brightened the holiday of over 3,000 seniors. IMGH also delivered over 15,000 donated items to seniors, including fans, household items, blankets and holiday gifts. The AniMeals on Wheels program delivers pet food to seniors with pets, so they will not have to share their limited food resources with their animal companions. Over 450 seniors and 1,100 pets participate in this program, with almost 85,000 pounds of donated pet food delivered by volunteers during this fiscal period.
The Meals on Wheels program received \$69,000 worth of donated facility space and \$48,000 worth of donated advertising services during this fiscal period.

4b (Code:) (Expenses \$ 4,126,734 including grants of \$ 2,538,294) (Revenue \$ 0)
The Refugee Services program assists in the resettlement of refugees fleeing their homeland in fear of political, social or religious persecution. Services provided include food, housing, transportation and medical assistance; donated furniture, home furnishings and clothing; cultural orientation and employment assistance; translation and educational assistance; and other services designed to help refugees become self-sufficient within six months of arrival in Houston. In this fiscal period, IMGH resettled over 880 refugees from 16 countries, 94% of whom were self-sufficient within six months.
The Refugee Services program received \$106,000 worth of donated refugee housing and \$77,000 worth of donated legal services in this fiscal period.

4c (Code:) (Expenses \$ 383,645 including grants of \$ 0) (Revenue \$ 27,121)
The Interfaith Relations program fosters understanding, respect and engagement among people of all faiths through educational opportunities and community service. Adult programming includes Dinner Dialogues, the Heart Anthology Art Event, and Spiritual Gatherings, with over 980 people participating in this fiscal period. Nearly 90 students participated in IMGH's youth programming during this fiscal period, including iLead, Houston's premier interfaith youth leadership program. The Interfaith Relations program also hosted or facilitated 45 community events, including faith tours and speaker panels.
The Disaster Preparedness and Response program works with nonprofits, religious institutions and government agencies year-round to prepare for disasters. More than 80 individuals from the Houston Interfaith Disaster Response Alliance (HIDRA) came together to learn about preparing for serious incidents, including hurricanes and school shootings.

IMGH staff closely monitors clients to ensure that they remain eligible for services, and that the services provided are effective in helping the client remain independent or become more self-sufficient.

IM Support was organized in August 2013 as a Texas nonprofit corporation to secure New Market Tax Credits financing for the construction of the W. T. and Louise J. Moran Building and the renovations of the Albert and Ethel Herzstein Building and to hold ownership of these properties for use by Interfaith Ministries for Greater Houston. Interfaith Ministries donated property and equipment to IM Support subsequent to the real estate transaction.

T. and Louise J. Moran Building and the renovations of the Albert and Ethel Herzstein Building and to hold ownership of these properties for use by Interfaith Ministries for Greater Houston. Line 4d represents assets donated to IM Support from Interfaith Ministries.

Volunteer Services - Interfaith Ministries received volunteer support from over 4,600 volunteers in this fiscal period. These volunteers donated almost 58,000 hours of their time in support of IM's program service areas. Volunteer opportunities include senior meal packaging and delivery, pet meal packaging and delivery, English language instruction and cultural orientation for refugees, interfaith event hosting, and senior disaster assistance.

Capital Campaign - Interfaith Ministries is in its third year of a multi-year capital campaign called Many Faiths Building Together. This campaign has enabled the organization to purchase a new headquarters building with space for a community conference center, as well as adjacent vacant land upon which a new Meals on Wheels distribution center has been built. As part of the campaign, IM has received \$35,000 in donated architectural and design services, \$37,000 in donated legal fees, and \$5,000 in donated fundraising services in this fiscal period.
