Outreach The Art Car Parade, introduced in 1988, has become a signature Houston event with a live audience of more than 250,000 More than 250 artists parade their wheeled creations for awed onlookers in a celebration of the ubiquitous automobile that turns Houston's streets into an open-air museum The Houston Art Car Parade has generated press in Der Spiegel, Smithsonian, Life, Vanity Fair, Autoweek, and the BBC's Top Gear, with extensive feature stories in newspapers such as The New York Times, The Washington Post, Los Angeles Times, Chicago Tribune, Detroit Free Press, and USA Today, not to mention coverage from French, Japanese, British, Korean, and German television crews The 2014 Parade (in FY 2013) generated \$2,038,171 in media ad value and \$6,600,000 in publicity value It is the oldest and largest event in a national calendar of art car programs It is also one of the largest public art events in the country, allowing people of every age and from every neighborhood to create and celebrate works of art using the car literally as a vehicle for self-expression
