THE MAJORITY OF NOEP'S FUNDING COMES FROM THE CANCER PREVENTION AND RESEARCH INSTITUTE OF TEXAS (CPRIT). ADDITIONAL FUNDING WAS RECEIVED FROM THE LIVESTRONG FOUNDATION, THE DEPARTMENT OF STATE HEALTH SERVICES, AND THE UNIVERSITY OF TEXAS.

NOEP EDUCATED 23,761 NURSES THROUGH OUR ONLINE CONTINUING EDUCATION STUDIES AND MARKETED EDUCATION TO 387,280 NURSES THROUGH MAIL, EMAIL, AND PRINTED MATERIAL HANDOUTS AT EXHIBITS. IN ADDITION, AWARENESS EFFORTS WERE TARGETED TO APPROXIMATELY 320,000 NURSES THROUGH THE
