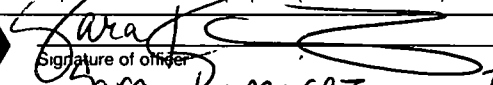

We offer services for victims of domestic violence, certain other crimes, and for victims of human trafficking. We employ a highly trained and professional staff that includes representatives accredited by the Board of Immigration Appeals as well as immigration attorneys.**4c** (Code:) (Expenses \$ 422,177 including grants of \$ 39,219) (Revenue \$ 291,789)Gabriel Project Life Center- Provides case management services to parents in order to give their children a healthy start at life. Services include free pregnancy testing, pregnancy services, emotional and material support and case management services until until the child's 1st birthday. As part of the educational classes, over 400 classes are offered throughout the year as part of our "Earn While You Learn" service. The "Earn While You Learn" service is a curriculum that that is used around the country and it covers all trimesters of pregnancy, birth, early parents skills, newborn care, breastfeeding, and bonding.
