SINCE THE WORKHOUSE'S INCEPTION IN 2008, VISUAL ARTIST HAVE BEEN OFFERED AFFORDABLE SPACE TO PRACTICE THEIR CRAFT AS WELL AS EXHIBIT AND SELL THEIR WORK. THROUGH ITS ADAPTIVE REUSE CONSTRUCTION EFFORTS, LAF HAS DEDICATED 6 BUILDINGS THAT CONTAIN ROUGHLY 56 STUDIOS AVAILABLE FOR RENT. IN 2014, LAF'S OCCUPANCY RATE WAS 92%.
