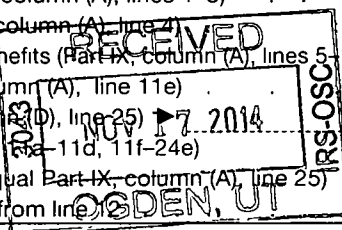

opportunities for the entire community, including students around the island. This master Plan Update includes focus on the
Hawaiian cultural practices around sea voyaging, sustainability (food growing and gathering), quality of life and
physical health through Hawaiian cultural activities (including Makahiki activities). Community meeting have been conducted
to solicit input.

2. We are working with The Trust For Public Lands and the Legacy Land Conservation Program, State of Hawaii to become stewards of
property which is part of an intact traditional Hawaiian hydrological system in Hakipu u. This acquisition will preserve the coastal
