| Houston Volunteer Lawyers Program - The Houston Bar Association established the Houston Volunteer Lawyers Program in 1981 to provide pro bono legal services in civil matters to low-income Houstonians who are the "working poor." They may have low-paying jobs, but do not qualify for federally-funded legal aid programs and in reality cannot afford even basic legal services. Seven years ago, the HBA established a new Equal Access to Justice Champions Program with the goal of increasing the number of pro bono cases handled by the Houston Volunteer Lawyers Program (HVLP) by at least 25%. To date 92 law firms, corporate legal departments and individuals have become "Equal Access Champions" by renewing commitment forms to handle a certain number of cases each year, for the next five years. HVLP has been able to more than double its representation in pro bono cases. In 2013, HVLP provided in-person, one-on-one legal advice to 4,000 applicants at no charge. The organization referred 1,278 cases to pro bono attorneys for long-term representation and assisted 7,100 pro se litigants at the Harris County Family Courthouse Booth. HVLP also screens applicants for eligibility, conducts initial interviews, provides counsel and advice, trains volunteers, provides mentoring services and monitors the status of cases. HVLP accepts and refers to volunteers in the areas of family law, property law, consumer law, tort law that is not fee generating, probate law and IRS tax controversies and US Tax Court representation. The HBA's HVLP continues its outreach to the Chinese and Vietnamese communities through legal clinics. The Consumer Law Task Force continues to provide advice and counsel and pro bono legal representation to families facing foreclosure, bankruptcy, credit problems and other consumer issues in tough economic times. Other special projects include the AIDS Unit, the Low Income Taxpayer Clinic, the Disability and Elder Law Unit, and the Veterans Legal Initiative. During this year, an additional \$60,000 grant was given to HVLP for Free Legal Advice Clinic for Veterans and spouses of deceased Veterans at the Michael DeBakey VA Hospital in Houston's medical center. | The Houston Bar Association's Juvenile Justice Mock Trial Program is now in its 38th year of teaching young teens about law and the legal system. As part of social studies, history, or government classes, students at over 40 participating schools in the Houston area work with the law students and HBA staff to learn about the procedures involved in a courtroom trial. Over a five-week period, the students develop their own case story and assume the roles of judge, jurors, attorneys, defendants, plaintiffs, and witnesses. At the end of the unit, the classes travel to the Harris County courthouse complex where they act out their mock trial in an actual courtroom. The program focuses on eighth grade students, but has worked with special classes of fourth, fifth, and sixth graders, including classes for hearing-impaired students.
