Disaster Relief - In October, 2013 a 7.2 magnitude earthquake and severe aftershocks hit Bohol, Philippines and 23 days later Typhoon Haiyan hit the same area The facilities of IDEA and a large area of surrounding communities were devastated in both damage to physical structures and in terms of the dramatic impact on individual lives and living conditions As special donations poured in, IDEA sprung into action to repair and restore their own operations and structures and in a greater way to provide relief in the form of housing through the construction division and by providing many types of food and other personal assistance to those in surrounding communities
